		confusion about the location of a healthcare program in the College of Business. This program is related more to administration than healthcare practices. The certificate doesn't require an undergrad degree and does not grant a master's degree. In other consent agenda discussion, it was pointed out that the Agriculture Entrepreneurship minor cannot be taken alongside an Ag major. And, the Accounting Grad Certificate is intended to make up any lack of credits for students interested in sitting the CPA exam. Mollie Rockafellow & Jordan Withers	Student Grievance Policy Changes (Discussion)	 Mollie and Jordan from Student Affairs presented most up-to-date refinement of Student Grievance Policy, with help from Kate Puckett, chair of Grievance Committee. The basis for the extensive changes to the policy is to build something that "reflects peer institutions and provides a framework that highlights the rights of students through the grievance process." Other concerns from Faculty Senate included grievance submission deadline (45 days after an incident), and the role of "supervisor" and whether that always indicates a dean. Most issues that could develop into formal grievances are resolved by an informal process between faculty and students. There are additional concerns about language specific to the rights of faculty to issue grades, which may be modified in advance of an FS vote on the policy changes at June meeting. Possible amendment posited by Jill Gibian to line 1.c.i: "Grievances submitted after the 45-day deadline may be considered at the discretion of the administrator overseeing the decision."

Rory Becker	Grant/funding tools/opportuni ties	 Rory Becker presented about grant opportunities. EOU's Pivot RP trial begins Monday, May 12 and runs for one month. Faculty are encouraged to use the resource to search for grant funds and let Rory know whether the search tool is useful enough for EOU to continue a subscription. Trial lasts one month. Title III funding opportunities include Experiential Learning course development grants (available as \$500 or \$1000 grants depending on credit load for course). Deadline for this grant is end of Week 10, spring term. Reporting and presenting at colloquium or convocation is requirement of funding. Additional Title III funding through an Experiential Learning Activity seed fund. This can fund up front non-capital equipment (less than \$5000) and can also be tied to searching for external funds. Reporting and follow-up is requirement of funding. 	
Pres. Kelly Ryan	President's report	 2029 Ascent Strategies to be presented in detail at June FS meeting. Key highlights of student success strategies: Mountaineer Information Center (MIC) growing in visitor numbers each term (100 for fall, 398 in January), trying to build out center as a place for asking questions. 3 to 4 individuals assigned to each student's "Mountaineer Success Team." Goal to meet all incoming on-campus freshmen. Next year goal: meet all new students. New Early Alert system is figuring out best ways to communicate with students. Alerts triaged by student guides, with committee 	



		looking to improve responses. 295 alerts in winter term and spring - "The more the better." Admissions - piloting early admissions agreements with La Grande, Griswold, and Umatilla. Piloting 2 more next year and assessing efficacy. Admissions - reduce time between admission and registration. Faculty worked to create 2 year schedules, which helps incoming students plan. Transfer advisor council looking at time gap between acceptance and registration. EAB gave us cohort analysis during their visit and we need to "support students on their journey."

CTLA has suggested changing new faculty orientation to have one day before term contract starts. Continue sessions with new faculty throughout the year.
