Recruitment Update

- Applications are on track with goals (12/7/20 43 applications); 1/21 next recruitment window closes. Need 25 applications to meet the goal for that window.

- Connecting with midtown community services and early childhood centers

Teacher Recruitment Update

- Plan: 17 employees
 - Application form will be live soon, and there is a plan to market positions locally and nationally.
 - Will be looking for people who have taught in schools like Atlas.
- Diversity of staff is a priority
- Hiring will be dependent on recruitment. Co-Founders will be conservative.

Facilities Update
