Maura asked about shifting language about “adapting to the market” as opposed to promoting liberal arts as good for competing in the market.

Troy said that he does not mean to shift our emphasis. Tim adds that he means “both/and” in the sense that we value the liberal arts but also have some more vocational programs in the context of the liberal arts.

Troy says that the feedback suggests that higher ed needs to do some cost containment. An emphasis on DEI, and on enrollment numbers.

🎬 FSEM Approvals – New Instructor Approvals for *Thriving in College* FSEM for Spring 2024/

What is *Thriving in College* FSEM and how is it being co-taught?

Miriam Liss explained that the course helps with building relationships, scaffolding assignments and how to review peer reviewed literature, present, and network with campus centers to scaffold course objectives. The FSEM may be co-taught with other faculty.

🎬 The UFAC recommends that the UFC create a task force to look at how different departments manage teaching loads and make recommendations for a way to calculate teaching loads that reflect our values as an institution.

UFC refers this study of teaching load equity back to UFAC at this juncture.

🎬 UFOC 2023 Report Recommendations

- o Revisit DBLC, DI/WI/SI

UFC will request the DBLC to consider reviewing its charge, and also reach out to the Provost for clarity on university online teaching guidelines and requirements. Discussion concerning this request included the history of DBLC from its beginning where very few faculty utilized an online teaching modality to present where faculty are generally using much more advanced technology, and are considerably more accustomed to teaching online. Whether a course should be taught online generally begins with a department or college conversation.

The UFC Chair discussed whether UMW faculty should combine the DI, WI, and SI committees for efficiency.

UFC will ask DI, WI, and SI committees for their thoughts on the issue of combining their committees.
