What This Is

This petition seeks to place the Nevada Election Integrity & PAC Prohibition Act (NEIPPA) on the 2026 ballot. If passed, it will:

- X Ban PACs from contributing to candidates, campaigns, and ballot measures in Nevada
- III Require full public disclosure of all campaign donors giving over \$200
- Solve Block dark money groups from spending in Nevada elections without transparency
- M Create strict penalties for violations, including fines and disqualification
- Section Election Finance Integrity Division (EFID) to enforce the law
- The Be effective starting January 1, 2026

Nevada Election Integrity & PAC Prohibition Act (NEIPPA)

Proposed Ballot Initiative for 2026 General Election

This initiative prohibits Political Action Committees (PACs) and dark money organizations from contributing to or coordinating with any candidate, campaign, or ballot initiative in the State of Nevada.

It bars candidates from accepting contributions or assistance from such entities and disqualifies organizations that fail to disclose all individual donors contributing over \$200 from making political expenditures.

The measure establishes an Election Finance Integrity Division (EFID) under the Secretary of State to oversee enforcement, investigations, and compliance.

Violations may result in civil penalties of up to \$50,000 per incident, disqualification from future elections, and, in cases of willful misconduct, felony prosecution.

All contributions over \$200 must be disclosed in real time through a state-managed online portal, including donor name, occupation, employer, and a signed declaration of non-coordination.

The Act applies to all state, county, and municipal elections and becomes effective January 1, 2026
