Since 2020, Safe YOU has operated in Armenia and Georgia, expanding to Iraq in 2021, and Romania, New Mexico (USA) and Poland in 2024. IMINI is committed to creating safe, supportive environments for vulnerable communities.

The consultant works closely with the technical team to address risks, implement updates, and continuously improve security features.

- Conduct daily monitoring of the cybersecurity status of platforms, including the Safe YOU app, to identify vulnerabilities or threats promptly.
- Ensure that all cybersecurity processes are under control.
- Maintain daily communication with the technical team to address risks, implement updates, and ensure continuous improvement of security features.
- Assess the platforms including Safe YOU app for risks related to user safety.
- Collaborate with developers to optimize features for user safety.
- Advocate for online safety and digital inclusion policies, focusing on combating TFGBV.
- Work with community organizations to adapt digital tools to the needs of women in the digital economy.
- Support the Innovation Consultant in developing the concept for a self-reporting tool for tracking real-time or post-incident TFGBV.
- Provide content-wise consultation throughout the program on digital literacy, digital security, and other relevant subjects.
- Consult on cybersecurity considerations during the wireframing and development of the TFGBV reporting/tracking tool and business toolkit.
- Participate in training activities and research requiring technical review and inputs.
- Develop content for the Safe YOU application and provide online consultations through the app's forums section.
