### a. Device and Technical Information

- Device model

- IP address
- Language and country settings

### b. Usage Information

- App interactions
- Pages or screens viewed
- Search activity within the app
- Session duration
- Ad engagement, including impressions, clicks, and completions

### c. Favorites and Local Preferences

- Watchlist or favorites you save in the app
- App settings and preferences stored locally on your device

### d. Third-Party Data

Our app may retrieve movie and TV metadata from third-party content providers such as TMDB or similar services. We do not claim ownership of that data.

## 2. How We Use Information

We use collected information to:

- Provide and operate the app
- Show movie and TV content
- Improve app performance and user experience
- Maintain app security and prevent fraud
- Measure analytics and app usage
- Serve ads and improve ad performance
- Comply with legal obligations

## 3. Advertising and Appodeal

**JK Animes** uses Appodeal as an advertising mediation platform. Appodeal and its advertising partners may collect and process certain data to serve ads, measure ad performance, and help prevent invalid traffic or fraud.

This may include:

- Advertising ID
- IP address
- Device information
- Approximate location derived from IP
- App activity related to ad delivery and engagement
