1. GENERAL FLEET PROTOCOLS

- 1.1. ALL SRP eligible fleets will operate under the command of an approved Fleet Commander, who will be present on site during operations.
- 1.2. FCs will undergo basic fleet command protocol training, and be approved by the Chief Executive Officer (CEO), Director of Operations (DirOps), or their designee.
 - 1.2.1. Mining Fleet FCs will have successfully completed the BIAMI PORPOISE skill plan, at a minimum. BIAMI ORCA skill plan completion is preferred. It is understood that someone who gains Mining FC status as a Porpoise pilot will work toward completing the BIAMI ORCA skill plan.
- 1.3. FCs will place mining fleet fees into the Ship Replacement Policy (SRP) wallet as soon as possible following collection.
- 1.4. Mining fleets will assemble at a predetermined location. Once assembled, SRP coverage will begin.
- 1.5. Fleets should travel in a manner deemed most reasonable by the FC.
- 1.6. For critical fleet operations, such as structure defense, and strategic operations, prescribed ship fits may be eligible for SRP while the SRP fee is waived. This determination will be made by a VADM or ADM only.

2. FLEET PARTICIPANT EXPECTATIONS

- 2.1. Fleet participants will follow all orders given by FC, including but not limited to: positioning, drone recall, and warp directions, target prioritization, and objective alterations.
- 2.2. Mining fleet participants will strictly adhere to the Mining Fleet SRP approved ship fitments when flying in non-HS fleets.
- 2.3. Fleet participants seeking reimbursement for lost ships will remit appropriate mining fleet fee to FC prior to mobilization, or upon initial rendezvous with an active fleet.
 - 2.3.1. Mining fleet fees will be dependent on the type of ship flown by the participant.
Further Information can be found in ANNEX A at the end of this document.
- 2.4. Fleet participants will conduct themselves respectfully at all times and follow all directions given to them by ranking officers, including FCs.

3. DEFENSE FLEET PROTOCOLS

- 3.1. Defense fleet ship doctrines will be announced by the FC prior to a fleet being formed.
- 3.2. Participants in the defense fleet will be expected to conform to the prescribed fit for that fleet.
- 3.3. The FC may prescribe a variety of ships for any particular fleet based on projected resistance, objectives, or adversaries.
- 3.4. The corp will make every effort to ensure BIAMI Defense Fleet doctrine ships are available via contract at HQ for members to purchase.

3.5. PvP Roam/PvE ships in a sanctioned fleet will be eligible for SRP IAW SRP doctrine

4. MINING FLEET PROTOCOLS

- 4.1. Mining fleets will be posted on the corporation calendar as soon as possible, and mail be sent out to alert membership of the upcoming fleet. A post should also be made in the proper Discord channel.
- 4.2. Alliance members will be allowed to participate in BIAMI mining fleets.
- 4.3. Mining fleets will Fleet Warp (FW) to the mining location unless doing so would constitute a security concern, to be determined by the FC following consultation with either the DirOps, Defense Officer (DEFO), or Mining Officer (MINO).
- 4.4. Away from Keyboard (AFK) mining is strictly prohibited
 - 4.4.1. Recourse resulting from AFK mining will be in accordance with (IAW) schedule found in ANNEX A
 - 4.4.2. Names of AFK Mining offenders will be tracked in a spreadsheet accessible by all BIAMI officers.
- 4.5. Whenever possible, mining FCs will pilot the boosting craft
- 4.6. Tag the ore you're mining with a unique identifier from other fleet participants.
- 4.7. Do not mine ore tagged by other players.
- 4.8. Do not 'pre-tag' ore you intend to mine before you are able to mine it.

5. HIGH SECURITY (HS) SPACE MINING FLEETS

- 5.1. HS mining fleets are not required to adhere to SRP fitments
- 5.2. HS mining fleets are not subject to SRP benefits, unless approved by the Mining Officer (MINO), DirOps, or CEO
- 5.3. HS Mining fleets are not subject to the SRP fee.

6. LOW SECURITY (LS) SPACE MINING FLEETS

- 6.1. LS mining FCs will make all efforts to ensure the safety of the participants
- 6.2. LS mining fleet ships will be replaced following destruction IAW SRP guidelines
- 6.3. Whenever possible, LS mining fleets will have at least two PVP/PVE ready platforms (defense fleet) present to provide defensive measures for the mining fleet against N/PC pirates/griefers/gankers
 - 6.3.1. Defense Fleets will have their own independent chain of command and FC and be placed in their own WING whenever possible.
- 6.4. LS mining fleets will, BEFORE fleet arrival on location, have PERCH, SAFE, and DEEP SAFE bookmarks in place in the CURRENT OP bookmark folder, and will ensure all participants have access to those bookmarks prior to undock.

7. NULL SECURITY (NS) SPACE MINING FLEETS

- 7.1. NS mining fleets will make all efforts to ensure the safety of the participants
- 7.2. NS mining fleet ships will be replaced following destruction IAW SRP guidelines
- 7.3. Whenever possible, NS mining fleets will have at least two PVP/PVE ready platforms (defense fleet) present to provide defensive measures for the mining fleet against both NPC Pirates as well as PC Harassment
 - 7.3.1. Defense Fleets will have their own independent chain of command and FC and be placed in their own WING whenever possible.
- 7.4. NS mining fleets will, BEFORE fleet arrival on location, have PERCH, SAFE, and DEEP SAFE bookmarks in place in the CURRENT OP bookmark folder, and will ensure all participants have access to those bookmarks prior to undock.

8. WORMHOLE (WH) SPACE MINING FLEETS

- 8.1. WH mining fleets will observe the same regulations as LS fleets with the following additions:
- 8.2. WH mining FCs will ensure fleet travel into and out of a wormhole will not exceed WH mass limitations
- 8.3. WH mining FCs will ensure that WH's lifespans are at least 4 hours long, and will direct evacuation prior to WH collapse.
 - 8.3.1. Further information on wormholes can be found in ANNEX A
- 8.4. WH mining fleets will ensure that at least one scan capable ship is present with the fleet at all times, as a precautionary measure against stranding

9. CORP SKILL PLANS

- 9.1. Corporation skill plans will be managed by DirOps with input from relevant officers.
- 9.2. Corp skill plans will be structured to aid the members clearly train for a single objective (i.e. a ship fit, mission, activity, etc.)
- 9.3. Alterations to corp skill plans will be announced to the corp via mail, to allow every member the most time possible to verify previously trained skills.
- 9.4. BIAMI will maintain a skill plan for every doctrine fit

10. SHIP DOCTRINES

- 10.1. BIAMI will maintain standardized ship fittings under 'corp fittings' for the most common and useful ships.
- 10.2. Not all ship fits will be SRP eligible
- 10.3. A complete list of ship doctrines can be found in game

11. ORE BUYBACK

- 11.1. BIAMI will purchase uncompressed ore, ice, gas, and PI resources from corp members for 85% Jita buy price.
 - 11.1.1. If you intend to sell PI resources to the corp, your production should be listed on the corps PI tracker to allow PI production adjustments to avoid overproduction or underproduction of any resources and enable the continuous industry capabilities of the corp.
- 11.2. Contract orders should be made to Brassum Industry and Mining Initiative
 - 11.2.1. Buyback contracts will only be accepted in the HQ station. However, BIAMI does provide freightering services within HS at a cost of 1M/100k m³/jump. Fractional loads will be rounded to the nearest 100k m³
- 11.3. Contract orders will include the Evepraisal.com permalink to the items at 85%
- 11.4. For more information on how to properly contract ore to the corp for Ore Buyback, see ANNEX B

12. CORP REPROCESSING SERVICES

- 12.1. BIAMI provides high level Ice, Ore, Gas, and Moon reprocessing at our HQ for a small fee. The fee will be the price of reprocessing plus 25% to go to the corp.
- 12.2. In order to request reprocessing services, contracts should be made out to Brynjar Brassum in a private contract in the HQ building for 0 ISK.
- 12.3. After the products have been reprocessed, it will be contracted back to you for 125% the price of reprocessing.

13. CORP MINING DAYS

- 13.1. In order to help support the corp, occasionally we will have corp mining days.
- 13.2. During these days, a corp mining fleet will be stood up, and members will be asked to join the fleet and donate a predetermined portion of their yield to the corp.
- 13.3. Events like this help the corp maintain revenue, permitting the programs and giveaways that make our corp great.
- 13.4. During these events, there will be giveaways to encourage attendance and camaraderie.

14. BPC REQUESTS

- 14.1. BIAMI has a number of BPO's fully researched. BPCs can be requested and provided based on the current research level of the BPO.
 - 14.1.1. Fully researched BPCs will cost (formula)
 - 14.1.2. BPC's that are notably researched will cost (formula)
- 14.2. To request BPCs, complete the form found on the BIAMI website, and an officer will reach out to you when the order is complete.

15. OFFICER REQUIREMENTS

15.1. Mining Officer (MINO)

- 15.1.1. BIAMI's MINO will have successfully completed the BIAMI MINING OFFICER skill plan, as well as be a registered Mining FC

15.2. Industry Officer (INDO)

- 15.2.1. BIAMI's INDO will have successfully completed the BIAMI INDUSTRY OFFICER skill plan.

15.3. Defense Officer (DEFO)

- 15.3.1. BIAMI's DEFO will have successfully completed the BIAMI DEFENSE OFFICER skill plan, as well as be a registered Defense FC.

1.8.1. AFK Mining Recourse Actions

- 1.8.1.1. 1st Offense: Verbal Warning
- 1.8.1.2. 2nd Offense: Written Warning; placed on 1 week suspension during which time no participation in mining fleets will be permitted.
- 1.8.1.3. 3rd and all following Offenses: Written Notice; placed on 1 month suspension

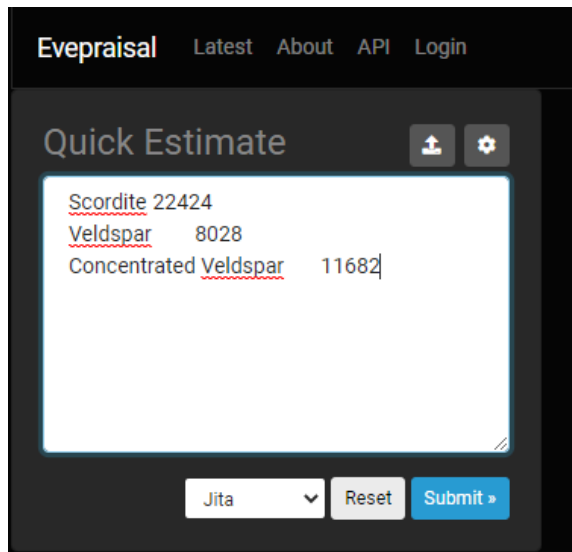
5.3.2.1. Select all uncompressed ore/ice to be contracted to corp by CTRL+clicking



5.3.2.2. Press CTRL+C


5.3.2.3. Open www.evepraisal.com

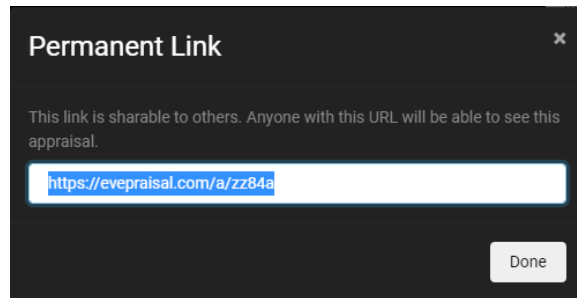
