Reflecting the substance of the whole contents of the article and enabling readers to determine relevance with their interest and decide whether or not to read the full document. The abstract consists of a statement about the background, the objective of the study or the focus of discussion, the method or necessary research steps, the findings and discussion, and the conclusion. The title and abstract are in English, in a single paragraph, single-spaced, Garamond 10, and are about 200 words maximum.

INTRODUCTION

The introduction should start without indentation using Garamond 12 bolded capital letters. Subheading is limited by two spaces within the body of the article. Please set your word processor to A4 format (8.27x 11.69 inches) with margins: bottom 3 cm (1.18 in), top 3 cm (1.18 in), left 3 cm (1.18 in), and right 2.5 cm (1.47 in). For the body of the paper, please use Garamond 12 with 1.5 line spacing.

In the introduction, explain the problem of the study and introduce the theories. The contents of the paper should be in the following: (1) title of paper, (2) author names and address, (3) abstract, (4) keywords, (5) introduction, (6) discussion and analysis, (7) conclusion, (8) acknowledgement (if any), (9) bibliography.

Do not number your paper. All text, figures and tables must be in English for an English article, and must be in Arabic for an Arabic article. It should always be written in Garamond 12, especially in the figures and tables. The article is 4500-7,000 words, including all pictures, tables, nomenclature, references, etc.

The introduction contains this important point: (1) What is crucial about the ISU (phenomenon) that needs to be written about (needs to be published): quantitative or qualitative (or both). (2) Is the (existing) writing not enough? Explain what others have ALREADY written and what has NOT been written (hence the need for this paper). (Previous research) (Novelty). (3) What is the (specific) purpose of the paper? (Is it different from others? The purpose of this paper is to COMPLETE the shortcomings of the existing paper.)=> focus of the paper. (4) What do you want to test (prove) in this paper? (argument or hypothesis that you want to test)

METHOD

The method consists of a description of the research type, data collection, data source, data type, and data analysis. It is written in paragraph form.

The method consists of 3 paragraphs that practically focus on and describe what has been done in the field. Research type and approach (see: Creswell), Research time, research place, data collection techniques (interview, observation, and documentation), informants, and data analysis techniques. Explain operationally.

RESULTS AND DISCUSSION

Findings (can be in the form of a subheading)

Inform a number of important data (original) fields obtained from questionnaires, surveys, documents, interviews, observations, and other data collection techniques. It can be completed with a table or graphic to clarify the result.

All figures and tables should be centred and numbered consecutively. Tables (refer to: Table 1, Table 2,...) should be presented above the table in centre alignment. A descriptive title should be placed after the table title (refer to: Table 1, Table 2,...) above each table. The source of the table should be placed below the table, right-aligned. Example:

$$C^2 = a^2 + b^2 \quad (1)$$

Analysis/Discussion

Presenting the data that has been interpreted and analyzed by a specific technique and has been processed by the specific theory (also from the researcher's idea).

Your discussion is the most anticipated part of the journal because you will elaborate on previous research and theory, thereby providing implications and recommendations for future research.

Citations in the Text should follow the APA, 6th edition, using manager references (Mendeley/Zotero).

CONCLUSION

Write succinctly and clearly the result of research, then describe the logical consequence in developing science and praxis of Islamic education. (Conclusion is not indented and uses bolded Garamond 12).

The conclusion contains the following important points: the most important finding of the research (something surprising or shocking) that was ONLY known after the research was conducted. Limitations of the research: limited sample, limited cases (only 3 cases), limited variation (not seen at different levels), limited locations, limited gender/age, limited methods (so that further research is needed that accommodates ... more varied cases ... larger samples ... for a deeper and more comprehensive understanding. With more in-depth and comprehensive results, more appropriate policies can be formulated.

Note:

1. A word that ends with a *ta marbūṭhab* (ة) is transliterated with or without “h”; if the word is the first part of a construct phrase, the *ta marbūṭhab* is transliterated into “t”.
2. An article *alif-lām* (ال) is transliterated into *al-*; if it takes place after a preposition, the article *alif-lām* is transliterated-
3. A Qur’anic verse is transliterated according to its pronunciation.
