Unless that happens, we are doomed to more of the same. As for gentrification from the labs, I think it's mostly a matter of commercial gentrification. The residential gentrification is more likely to reflect

the forthcoming demolition ordinance, which authorizes by-right demolition of any single-family home as long as the new structure is denser. West Berkeley is at the greatest risk, because the land there is less expensive than elsewhere in town. Of course it's also a threat in the hills, where no more housing of any sort should be built due to evacuation and wildfire problems. The council is pro-growth, and UC is the greatest source of growth in Berkeley. Unfortunately, the state Legislature and now the CA Supreme Court (see the recent decision on the People's Park lawsuit) is totally on board with UC expansion. Bad news all around.
