#### V. Old Business:

A. Host and Chat Posting Volunteering (8 min.) (Discussed three times on 05.31.24, 11.30.23, 04.30.24)

Possible Motion: Designate an individual who can investigate both a group inventory process and an external facilitator.

C. AA's Big Book and 12X12 (discussed once, 11.30.23)- The group is considering whether to reference AA's Big Book and 12X12 in their meetings to allow members to share insights, strength, and hope gained from these texts. At the first discussion, there was a consensus within the group to maintain focus within Al-Anon and discourage reading from the AA book during their meetings. Instead, they recommend interested individuals attend dedicated Al-Anon Big Book meetings to preserve the distinct nature of Al-Anon meetings. Possible motion: Constrain references to literature to Al-Anon literature only.
