I AM recognizes the concerns of living, healthy men, women and children on the planet/plane, which led me to internalize them in their organizations. Certain details that are not acceptable.

The preamble to the Constitution of the World Health Organization features phrases such as:

- 1- cooperation
- 2- responsible government
- 3- contracting parties

1- the word cooperation, the etymology of the word cooperation is "action and effect of working together". Its lexical components are: the prefix co- (with, meeting, union), operari (to work, operate), plus the suffix -tion (ción) (action and effect). See: prefixes, suffixes, other Latin roots, cooperate, opera and also worker. And the etymology of the word *work*, indicating labour, in most European languages originate in an imagery of compulsion, torment, affliction and persecution. The French word *travail* and Spanish *trabajo*, like its English equivalent, are derived from the Latin *trepaliare* – to torture, to inflict suffering or agony. The English "work" has an Indo-European stem *werg-*, via Greek *ergon*, meaning deed or action. It is cognate with Gothic *wrikan*, to persecute, and Old English *wrecan*. Thus, in the word "work", violence is latent, and it appears in the form wreak. We must never forget The Universal Declaration of Human Rights, that is, one and everything that surrounds the Homo-Vivo and; neither the WORLD HEALTH ORGANIZATION, nor the UNITED NATIONS ORGANIZATION, nor the WORLD HEALTH ASSEMBLY can ignore that fact.
