

NOTICE-CUM-CONSENT FORM

This notice-cum-consent form (“**Form**”) is issued under the applicable data protection laws of India, and pertains to the collection, processing, and sharing of any data which is related to me and that makes me identifiable (hereinafter referred to as “**Personal Data**”). By affirming this Form, the undersigned hereby permits **Škoda Auto Volkswagen India Private Limited** and its group companies, subsidiaries, affiliates, etc. (hereinafter referred to as the “**Company**”) to collect, process, and share the Personal Data for the purposes specified herein.

It is clarified that the Company may appoint an authorized and licensed agency as its data processing partner, to undertake the activities of collection or processing of the Personal Data at its behest in certain situations (hereinafter referred to as the “**Data Processing Partner**”). Such Data Processing Partner shall provide this Form to the Company at the time of, or prior to the collection or processing of any Personal Data by the Data Processing Partner, to ensure that the consent of the undersigned is obtained in the appropriate manner.

It is further clarified that the Personal Data for the specified purposes mentioned herein shall be collected only by the Company, or the Data Processing Partner, as the case may be.

I have visited the Company’s privacy policy (along with its amendments from time to time), and shall have an access to any other policy of the Company that may be notified from time to time for the implementation of privacy policy (“**Policy**”) which are also available on its website at www.skoda-auto.co.in, and have understood the contents thereof.

In this regard:

1. I understand that the Policy mentioned in the paragraphs above provide detailed information about how the Personal Data may be collected, used, accessed, and disclosed.
2. I understand that the Personal Data will be used, accessed, or processed only in accordance with the Policy and the applicable laws of India.
3. I agree to providing the following Personal Data:
 - a) *Name, contact details, and identity proof;*
 - b) *Any other data voluntarily provided by me.*
4. I am providing the Personal Data with free, specific, informed, unconditional and unambiguous consent, and only for the following purposes:
 - a) *Sale of products and services;*
 - b) *Use of the Company websites;*
 - c) *Providing customer support to the undersigned;*
 - d) *Collecting information about behaviour and commercial habits of the users to improve the services offered; and*
 - e) *To participate in the Kodiaq RS contest organised by the Company and to participate in the expedition organised by the company for the winners of the contest.*

- f) Promotion / advertisement of the Company's products and services by way of publication / display of the photos / videos captured during the participation in contest and the expedition in various print media, television and social media handles of the Company.*
- g) I agree that my name, address, telephone numbers, e-mail identities or any other information that is provided by me, can be shared by the Company with other third party service providers associated with and/or assisting in organizing and administering Contest. I understand that Company may replace the service providers with other service providers at Company's own discretion. The existing and the replaced service providers, if any, shall be bound by similar level of obligations to process and safeguard and delete my personal data as the Company is.
5. I understand that the Personal Data so collected will be retained only as long as necessary to fulfill the specified purposes or as required by applicable law. Upon expiry of the retention period, the Personal Data will be securely deleted or anonymized by the Data Processing Partner and/or Company, as the case may be.
6. I acknowledge that I have the referred rights provided below with regard to the Personal Data collected under this Form:
- a) Right to withdraw/revoke my consent;
 - b) Right to file grievances with the Data Protection Board;
 - c) Right to be informed of a breach of Personal Data;
 - d) Right to use a consent manager;
 - e) Right to contact the data protection officer;
 - f) Right to access information about the Personal Data provided;
 - g) Right to correct/modify/erase the Personal Data provided;
 - h) Right to nominate others to exercise my rights.
7. I understand that I have the right to revoke my consent at any time in the manner specified under this Form, and such revocation shall not affect the legality of processing of the Personal Data based on my consent before such withdrawal.
8. I understand that I may exercise my rights as a data principal, including but not limited to my right to manage my consent, right to seek further clarifications/information, and right to grievance redressal (either with the data protection officer or the Data Protection Board), by contacting the Company through the following communication channels:

I understand that the terms of the Policy may change, and I will be notified of such change (*either through an announcement on the Company's website at www.skoda-auto.co.in or via an intimation over my email address provided hereunder*) before or at the time of any further use or processing of Personal Data that takes place.

I understand and agree to the Data Processing Partner collecting, using, gaining access to, and disclosing the Personal Data sought under this Form, whilst providing data processing services to the Company in a manner that is in accordance with this Form, Policy and the applicable laws of India. Having read and understood the points mentioned above, I consent to allowing the Data Processing Partner and/or Company (as the case may be) to collect, use, share or process my Personal Data as

may be necessary for the Data Processing Partner to provide its data processing services availed by the Company.
