As we grieve, we also turn our attention to the future and to what must be done to see that no one else suffers or dies at the hands of those charged with protecting and serving.

In doing so, MICAH will be reaching out, calling **each and every week** to ask what it is your department is doing to rid itself of the failing policies and procedures, to reinforce compassionate and service-oriented actions, and to change the culture of first responders in our beloved Memphis.

MICAH leaders will be reaching out, asking, "What policy or budget change has (MPD/ MFD/ SCSO/City Council/ City Mayor) made since Jan 7th, 2023 to avoid future harm and death during individuals' encounters with law enforcement?"

MICAH will be reporting out your responses in a Countdown for Change on its website for the next year.
