BEHAVIOR AND DISCIPLINE CODE PHILOSOPHY

The Illini West School District #307 behavior policy is designed to promote collaborative efforts between students, parents and school personnel to establish and maintain a positive learning environment characterized by respect for oneself, others and property. By reinforcing positive behaviors, correcting negative behaviors, and guiding the student decision-making process through use of related and logical consequences, our goal is to teach students to make decisions which will make a positive impact upon their own lives and the total school environment.

BEHAVIOR AND DISCIPLINE CODE PROCEDURES

The provisions of this Behavior and Discipline Code reflect the status of the policies, rules, practices and procedures as currently practiced in the Illini West School District #307. The administration reserves the right to interpret, apply and modify these procedures as deemed necessary to promote a safe and positive learning environment for students and staff.

Consequences for behavior infractions may be assigned following investigation of an incident and considering the totality of the circumstances. Behavior which negatively affects the learning environment or negatively impacts a legitimate school interest will be addressed and consequences assigned. The Behavior and Discipline Code encompasses behavior on or adjacent to school grounds before, during or after school at any school-related event.

BEHAVIOR AND DISCIPLINE CODE COMMITTEE

The Behavior and Discipline Code Committee consists of administrators, Board of Education members, teachers, parents, and students. This committee reviews the Behavior and Discipline Code annually. The members of the 2023 review committee are:

After School Detention

The student is required to spend non-class time in a school-designated area.

Alternative Placement

The student is assigned to a supervised alternative site for instruction.

Bus Behavior Intervention Strategy

The student is temporarily excluded from riding the school bus for a specified amount of time. Bus suspension decisions will consider maintenance of a bus environment conducive to protection of the health, safety and welfare of students and staff.

Expulsion

The student is prohibited from attending school or any school-related activity and from being on school property for a period of time designated by the school board.

In-School Suspension (ISS)

The student is assigned for a specified time to a supervised, designated area of the school or school property. The parent will be notified. Any assignments are eligible to be made up consistent with the Excused Absence policy in the Student Handbook.

Loss of Privilege

Loss of privilege may include the loss of common time or passing time privileges and/or the student is not permitted to attend any extra-curricular activities except those required for class, (i.e. band performances), for a designated number of days. Other examples include, but are not limited to, confiscation of the student's cell phone, restricted open campus lunch, or student parking. The parent will be notified.

Lunch Detention

The student is assigned for a specific time to a supervised, designated area of the school during their lunch period.

Out of School Suspension (OSS)

The student is temporarily excluded from school and school-related activities and from being on school property for a specified amount of time. Suspension decisions will consider maintenance of a school environment conducive to learning as well as protection for the health, safety and welfare of students and staff. The parent and superintendent will be notified. Any assignments are eligible to be made up consistent with the Excused Absence policy in the Student Handbook.

Parent Contact

The teacher notifies the parent of the student's inappropriate behavior.

Parent-Administrator Contact/ Conference

The Principal or Director of Student Services discusses the student's behavior with the parent. The teacher and the student are included at the discretion of the Principal/ Director of Student Services and parent.

Parent-Teacher Conference

The teacher and parent meet to discuss the student's behavior. The student is included at the discretion of the teacher and the parent.

Police Notification

The police are notified by an administrator when a student engages in a behavior which is illegal, endangers the welfare of students or staff, or threatens serious disruption of the educational environment.

Related and Logical Consequences

The student is assigned logical consequences which have a relationship to the behavior infraction and are intended to teach appropriate decision-making. Consequences may include, but are not limited to, assignment of school-related tasks to be completed during non-class time, assessment of monetary damages, or loss of credit on assignments.

Student-Teacher Conference

The student is informed that a behavior is inappropriate.

BEHAVIOR AND DISCIPLINE CODE PROCEDURES

The following procedures correspond to the Behavior and Discipline Code and represent responses and consequences for inappropriate student behaviors. In general, responses and consequences progress in levels of intensity; however, they are not intended to necessarily be sequential. Explanations of the individual procedures accompany this document.

^{*}Repeated occurrences of any behavior or incidents involving multiple infractions will increase the level of its consequences.

	Causing a substantially detrimental effect on the student's or students' physical or mental health. Substantially interfering with the student's or students' academic performance; or Substantially interfering with the student's or students' ability to participate in or benefit from the services, activities, or privileges provided by a school.
