### ❖ **Coursework**

- **US Constitution Requirement:** More information on this requirement can be found at: [U.S. Constitution Requirement](#)
  - **If met via AP credit:** upload unofficial transcript highlighting you have met this requirement
  - **If met via examination:** upload certificate of completion.
  - **If met via coursework:** within the application, indicate the course that meets this requirement using the course prefix, course number, course title, institution where course was taken, grade, and term course was completed (eg. *POLS 150 American Political Institution, CSUCI, Spring 2020*).

- **Credential Prerequisite Courses (17 units)- No upload required.** Must be completed or in progress at the time of application. All [credential prerequisite courses](#) must be completed with a C or better prior to enrolling in Phase II of the program. All prerequisite courses must be taken within 7 years of credential program application.
  - **Bilingual Authorization Candidates** are required to complete an additional 9 units of prerequisite courses.

❖ **45 Hours of Field Experience**

- **No upload required.** Fieldwork experience can be met by successful completion of 45 hours of pre-service (supervised participatory observation) in either EDMS 422 or EDSS 424 (or equivalent).

❖ **Credential Program Interview**

- Guidance on the interview requirement will be provided during the application review process.

❖ **Basic Skills Requirement (BSR)**

- **No upload required.** A Bachelor's degree or higher degree from a regionally accredited institution meets the Basic Skills Requirement. See [PSA 24-07](#) for details.

❖ **Baccalaureate or higher degree**

- A bachelor's degree or higher degree from a [regionally accredited institution of higher education](#).

❖ **Official Transcripts\***

- An official transcript (paper or e-transcript) from each college and university attended must be submitted directly to the Admissions Office at the address noted below. Transcripts submitted to credential counselors will not be reviewed/accepted.
  - *Former and current CSU Channel Islands students do not need to submit CSUCI transcripts.*
  - *Applicants who have previously applied to Cal State Channel Islands and submitted their transcripts more than one year ago must resubmit their transcripts.*
  - *Individuals who have completed college or university course work at an institution in a country other than the United States must obtain a complete evaluation of foreign transcripts prior to applying for a California credential. [Official CTC information](#)*

**Note:** Candidates intending to apply to our intern program or any credential program for their clinical experience must hold a baccalaureate degree or higher from a regionally accredited institution of higher education.

❖ **Minimum GPA Requirement**

- GPA must be 2.75 in the last 60 semester units completed or 2.5 cumulative.

❖ **Certificate of Clearance from the Commission on Teacher Credentialing**

- Upload a copy of your Certificate of Clearance with your application. **Please do not upload your Live Scan Form (41-LS) with your application.**
  - This requires a 2-step process. Please anticipate up to a month for this process to clear. [Click here for Certificate of Clearance Instructions](#)

❖ **Tuberculosis (TB) Clearance**

- Upload a copy of your Negative TB test result. **The TB Risk Assessment Questionnaire is not accepted for the credential program.** A negative TB result must be current for the duration of the credential program. TB results are valid for 4 years.
  - Your document must include 1) Your first and last name, 2) the facility, 3) date the test was administered, and 3) the date the result was read (for skin tests).

❖ **Personal Statement**

- A written statement of purpose (500-600 words).
- Please include all of the following:
  - your personal and professional reasons for seeking a credential
  - reflect on how your previous experiences have prepared you for this program
  - reflect on how this program will allow you to develop the knowledge and skills to achieve your personal and professional goals.
- Your statement will be evaluated for accurate grammar, spelling, and the ability to communicate effectively in writing.

❖ **Advising session verification**

- Upload verification of attending a [30-minute "first-time" or "follow up" advising appointment with a credential counselor](#). **(attendance to 15 minute Application Assistance will not meet this requirement)**. Verification letters will be emailed to individuals once an advising session has been completed.
  - Select "Program Materials", then the "Documents" Tab
  - Upload verification using the "other"

❖ **Two Letters of Recommendation**

- Phase II applicants must provide TWO letters of recommendation by the Phase II application due date.
  - Recommendation letters are not uploaded by applicants– there is a process configured via the Cal State Apply application system: [Letters of Recommendation Instructions & Requirements](#).

❖ **Subject Matter Requirement (SMR)**

The CTC provides more information on [how to satisfy this requirement](#). The Subject Matter Requirement can be met by one of the following:

- **Passing CSET exam scores:** Upload passing CSET score reports. Information about CSET Exams can be found on the [CTC website](#).
- **Qualifying Degree:** Upload unofficial transcript showing the SMR has been met via [qualifying degree/major](#).
- **Coursework Evaluation:** Upload complete SMR Coursework evaluation: Coursework must be aligned with all [Domains in Subject Matter Requirements](#) related to your credential areas. Contact your Credential Counselor for a coursework evaluation template relevant to your credential area. This will be submitted to the Associate Dean along with your transcripts.
- **Completion of Subject Matter Program:** Upload Signed Subject Matter Waiver from an approved Subject Matter Program.

**Bilingual Authorization (BLA) Candidates** are required to meet the Spanish Language Subject Matter Requirement. Use the “Supplemental Materials” Field of the Documents section to upload one of the following:

- [CSET Spanish III](#) passing score report.

#### ❖ **Letter of Good Standing**

- If you have previously been enrolled in a credential program and did not obtain your credential, you must submit a letter of good standing from the program attended as part of your application packet.
  - Use the Supplemental Materials Field of the Documents section to upload your Letter of Good Standing.

#### ❖ **Internship Pathway (Education Specialist Only)**

- Effective October 30, 2025: We do not offer an intern pathway for the Education Specialist Credential Program. The intern pathway has been placed on inactive status with the Commission on Teacher Credentialing.
