IMMIGRATION LAW PASSED NEW LAW LEGALIZES VASSAL STATUS OF FOREIGN NATIONS LAW PARTIALLY AMENDED TO MAKE PALATABLE TO SOFTER CITIZENS

(ISTANBUL) The first legislative session successfully concluded with the passage of a great deal of new and important Ottoman laws, directives, and amendments, none more so than the Law of Ottoman Immigration, Nationalization, and Subjugation ([LOINS](#)) The law as written allows for mild foreign participation in the vital business of the Ottoman economy- all the better to show them the light and pressure them into assimilating, while also allowing unlimited full immigration into our universalist nation. However, for those who desire greater participation (and money) than a simple Konuk, who may not vote (Konuk being a new category established in conjunction with a successful constitutional amendment, the [Citizenship Legislative Flexibility Amendment](#))-

OTHER LAWS PASSED NEW LAWS DEAL WITH FINANCIAL, PENAL CRIMES, TRANSPARENCY

-and less than a full Ottoman Danişman, they may enter a lottery (which Danişmanlari may bid on) to become a Misafir, who has more money and more voting rights, while still well-short of a full citizen. Unfortunately, a section of the law banning treasonous foreign citizens infiltrating our society under the guise of citizenship was stricken in order to make sure the law could be passed. This is the nature of legislative politics. Such is our new law relating to individual status. With regards to foreign nations, however, the system is slightly different. If a nation collectively submits to Ottoman rule, they will all escape the sortition process and immediately become Misafirler with 80 Lira- more than the simple 10 of a Konuk or 30 of a normal Misafir- and their enlightened leadership who generously brought them under our grasp will be rewarded with 100 Lira as Misafirler. This policy will no doubt lead to mass submission and vassalization of the wild barbarian before our splendid state.

-Fitting with their broad common-sense nature, they were passed overwhelmingly, with the lowest margin being for M. Incesu's Grand Bazaar Transparency Act and M. Incesu's Grand Divan Transparency Act, both of which passed by about ten points, and both of which guarantee general public records for mercantile and civil votes and actions. Several amendments were also passed, including the previously mentioned [Citizenship Legislative Flexibility Amendment](#), which allowed for our unique immigration system, and the [Impeachment and Minor Edits Amendment](#), which clarified some grammar, and strengthened our noble impeachment process.

We refer specifically to the newly-passed law, the [Ottoman Recoding Initiative](#), sponsored by M. HKim, which mandates that our most private and secret national secrets be, after a short period, be laid bare publicly for foreign nations (under no such obligations) to gawk at and plot military campaigns against.
