Dear University Officials and Relevant Administrators,

We, the undersigned students of The George Washington University are profoundly outraged by not only Clarence Thomas's lack of humanity but also his official suggestion to reconsider the cases to which the right to contraception and the right to queer existence is protected. In response to yesterday's email, we do agree that professors should have "academic freedom" and "freedom of expression and inquiry"; but there is a great difference between the freedom of expression of professors and a Supreme Court Justice stating that it should be legal to strip his queer students of not only their expression but to allow their existence to be criminalized. As the Justice and Law professors may know, not all speech is protected; according to the U.S. Department of Education's Notice of Interpretation on June 16th, 2021, discrimination on the basis of sexual orientation and gender identity is one of those instances in which speech is limited. Furthermore, additionally under Title IX, individuals cannot be discriminated on the basis of sex. We, the student leaders of the George Washington University, find it quite difficult to imagine Professor Clarence Thomas wouldn't be biased in the classroom if he is actively trying to strip individuals with uteruses of the right to medicine and queer individuals their right to legally exist.

In the Student Code of Conduct itself, the university tells us that they do not permit unlawful discrimination on the grounds of age, color, disability, gender, gender identity or expression, genetic information, marital or familial status, pregnancy, race, religion, sex, sexual orientation, and/or other characteristics protected by applicable law in any university recognized area of student life. Attending classes is a university-recognized area of student life; an area where students of such protected groups specifically have the right not to experience discrimination.

We strongly urge the administration to rethink not removing Clarence Thomas from his position on the basis that students will not be free from discrimination in his classroom considering he himself is trying to strip students with *protected characteristics* of their legal right to healthcare and existence merely on the basis that they exist with such *protected characteristics*.

Academic freedom means to learn freely and fairly- absent of discrimination. As members of the university, this open letter is our contribution to "the critical discussions that are foundational to our academic mission". The students of The George Washington University are the very foundation upon which the academic mission stands. Without it, not only would the academic mission not exist but neither would the university or payroll from which Clarence Thomas is paid. We ask the university to change its mind both because the students are calling for it and because it's the right thing to do.
