# 2022 HB 5 SB 124- Fetal and Infant Mortality Reduction - support

This bill reduces legal abortions from 24plus to 15 weeks in Florida with no exceptions. At 15 weeks the baby is fully developed (will be growing and developing the rest of the pregnancy), the sex can be detected, and a mom can begin to feel the baby moving. Not the most pro life bill but a step in the right direction. Listening to proabortionist you would think abortions were being outlawed (not yet!!) - based on statistics only about 3% of abortions happen after 12 weeks.

Representative Susan Valdez of Hillsborough – a Catholic was asked by the Democrats to take the lead the debate.

**HB 5** is the single most important legislative bill that must be passed this session.

Voting yes will save over 4,000 babies' lives in Florida and hopefully more next year with the passage of the heartbeat bill.

Pro-Abortionist claim abortion is healthcare but how can taking a baby's life be healthcare?

At 15 weeks or almost 4 months the baby is a person. Facial eyebrows and eyelashes are developing, the bones are coming stronger, and the baby begins to stretch and move. And ultrasounds can now reveal whether God created a boy or girl. Yes, a unique human different from his mother and father.

We can all agree life is precious.

Because life is precious, doctors and healthcare provides need to educate parents especially the mother on caring for the baby before it is born. I noticed this bill mentions tobacco education 34 times but no where does it reference alcohol or marijuana. These are the three most common abused drugs that directly impact a baby while in the womb and often throughout their life. Pregnant women are even warned against using caffeine but not marijuana a mind-altering substance that stays in the body far longer than most other drugs.

Marijuana smoke contains many of the same respiratory disease-causing and carcinogenic toxins as tobacco smoke, often in concentrations several times greater than in tobacco smoke. While tobacco use is decreasing, marijuana use is skyrocketing due to the low cost of marijuana, availability, marketing exploitations and lack to educational resources.

New longitudinal studies are able to research higher THC levels effects on the baby. They have discovered that prenatal marijuana use was associated with a 50 percent increased chance of low birth weight regardless of tobacco use during pregnancy. Other risks include premature births, respiratory issues, plus children often experience deficits in memory, reasoning, concentration, hyperactivity and mood disorders to mention a few issues. Many of these issues are the same ones people who use marijuana experience when they get high. Not one study recommended using marijuana during pregnancy.

Why is all this important? Florida is 3 times the national average for pregnant women using marijuana. THIS IS A CRISIS AND MUST BE ADDRESSED. Florida's doctors are recommending the use of marijuana and often recommending it for nausea when far better, safe alternative medicines exist. This is disconcerting especially because medical marijuana in our state has no cap on THC levels and the increase cases of marijuana-induced psychosis throughout our state.

It is imperative we protect babies and mothers. You have an opportunity here to require marijuana educational tools to prevent marijuana spectrum disorder to be added to the list of "developmental disabilities."

Please support this bill and amend requiring strategies for eliminating use of maijruana before, during and after pregnancy. We must prevent marijuana spectrum disorder from being added to the list of 'developmental disabilities' in the future.
