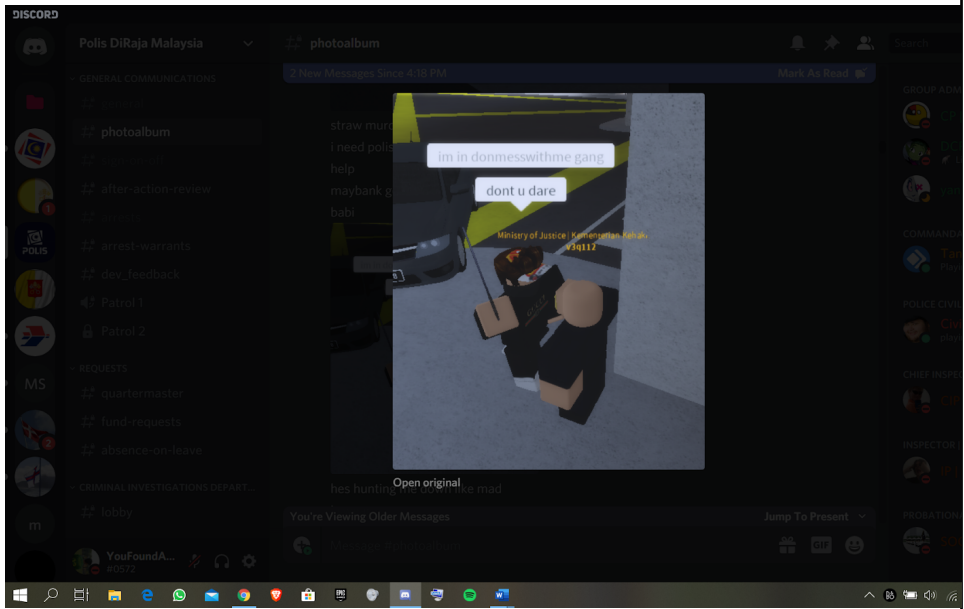
Case Facts:

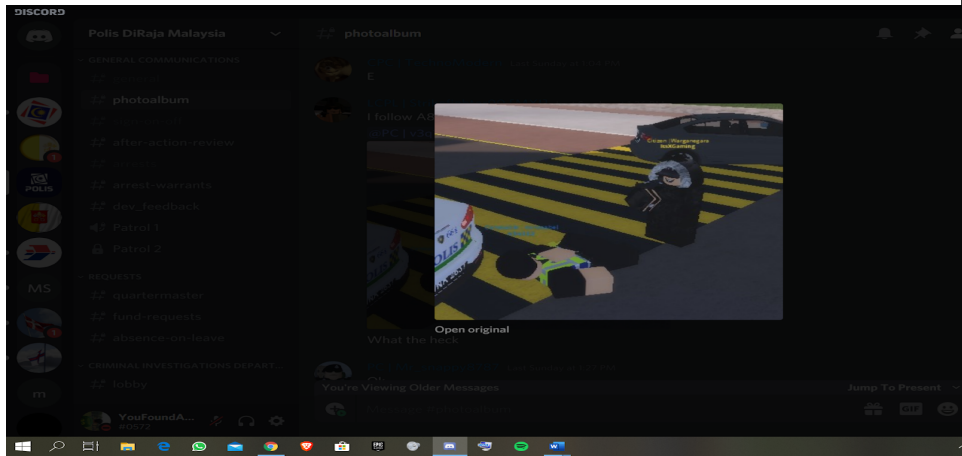
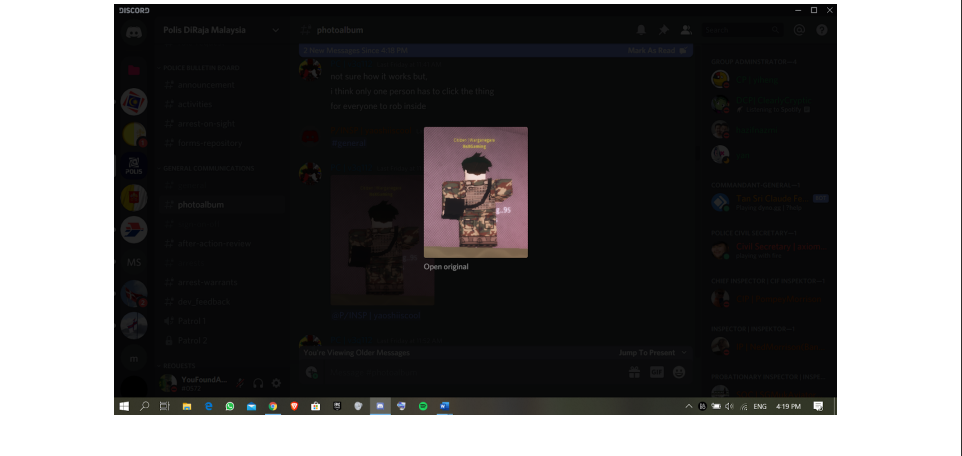
- I. D/CPL Ham_Marksman was responding to a shootout at Dataran Merdeka, Kuala Lumpur. En route to the scene, he heard multiple gunshots together with a radio

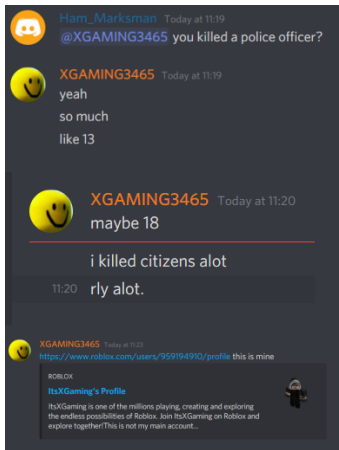
transmission notifying him of officers that were gunned down. As D/CPL Ham_Marksman came closer to the source of the gunshots, he witnessed DonMessWithMe4 armed with an MP5. The gunmen then shot a few rounds aimed toward the vehicle driven by the officer and killed him. *[Refer to Annex A]*

- II. As the shootout continued, strawbeuri procured a parang and proceeded make threats towards off-duty police officer, v3q112. *[Refer to Annex B and C]*
- III. DonMessWithMe4 and his accomplice were seen on the top of the TransitKL's office roof. One of the shooters jumped down after exchanging shots with L/CPL YouFoundAlexx to distract him, DonMessWithMe4 then advanced and murdered the officer. *[Refer to Annex D]*
- IV. Acted on the information given by Inzun for the location of DonMessWithMe4, L/CPL YouFoundAlexx rushed to the location and was caught off guard. The shooter wounded the officer, approached him, said "Bye" and ended his life. *[Refer to Annex E]*
- V. While on duty, PC v3q112 was informed of a gunman named ItsXGaming through the radio. The officer then rushed to the scene; arriving first. The gunmen replicate his boss's action of taunting the victims before delivering the final blow. *[Refer to Annex F]*
- VI. Gang member, ItsXgaming was caught in a bank vault taking cash assets from the bank. *[Refer to Annex G and H]*
- VII. CPL JimboMorrison resumed his duty at Dataran Merdeka. He was on foot patrol with cadets under his supervision CPC Mr_Foneic, CPC Cl_ashAviator, and Zero_Pulse. The group was then approached by gang member Hafiysoldier1123ALT, the suspect then gunned down CPL JimboMorrison. *[Refer to Annex I]*
- VIII. Once again, Hafiysoldier1123ALT could be seen fatally shooting CPL JimboMorrison. *[Refer to Annex J and K]*
- IX. Gang member, ItsXgaming admitted that he had gunned down multiple officers. *[Refer to Annex L]*
- X. Donmesswithme4, Hafiysoldier1123ALT, and MINGHANOFNANHWA were seen driving around together.. *[Refer to Annex M]*
