

## Template for Certification Letter of BABA-Compliant Supply Under the Limited Nonavailability Waiver for Solar for All Modules

## NATIONAL SOLAR FOR ALL NETWORK

What: This document is a template that manufacturers can use to certify to developers, program administrators, and Solar for All grantees that their products are in compliance with the 2025 temporary BABA waiver that EPA issued for the Solar for All program.

The temporary <u>EPA waiver</u> does NOT waive all of the manufactured product requirements but instead requires domestic assembly only. The waiver is available ONLY for solar modules, and it is valid between January 10, 2025 and December 31, 2025. Solar modules under the waiver in the Solar for All program must be installed, i.e., "permanently fastened to an outdoor support structure at the project site," by June 30, 2026.

This document should \*NOT\* be used as a template to comply with BABA outside of the limited 2025 EPA waiver. You should only rely on public sources for the rules applicable to the program. Additional information is available on the <u>CESA website</u> to help introduce those who are not familiar with BABA as well as other relevant material.

Who: This document can be used as reference by grantees, both prime and subrecipients, contractors, solar manufacturers, administrators, and other stakeholders involved in program implementation.

Note to manufacturers and utilities: BABA and "Buy American" standards are not the same. Meeting "Buy American" or other standards such as the domestic content requirements for tax credits does not mean you comply with BABA. While EPA does not require a specific certification form, your letter must explicitly reference BABA, even if your product falls under the limited waiver.
