## Chapter 1

### **THE PROBLEM**

#### **Introduction**

*This paper is designed to help you understand the formatting and organization of an APA style research report. Each section of the report is described in its appropriate location within the report.*

*The Introduction is the first paragraph of the main text of the report. The Introduction's objectives are to (a) describe the study's purpose, (b) situate the study in relation to earlier research on the subject, and (c) support your hypotheses (Smith, 2006). The reader should understand the purpose of the study and the hypotheses you are advancing with each paragraph of the Introduction.*

*The general subject of the study should be introduced in the first paragraph of the introduction. Don't start out too broadly (like by talking about psychology as a whole), but don't start out either too specifically either (e.g., by stating the hypothesis). Any terms you use that are particular to the field of study should be defined. Give a brief description of your operational definitions.*

*In subsequent paragraphs, you should be building a case for your study.*

*Explain what has been found in previous research on this topic,*

*Describe what gap exists in this literature, and explain how your study will fill the gap (i.e., provide a unique study that will contribute new knowledge in the area).*

## **Statement of the Problem**

*In general, this study aims to investigate the relationship among identity orientation, meaning in life, and academic performance. It specifically seeks to respond to the following questions:*

*Described your problem statement and hypotheses. The problem that your thesis will address should always be defined before you write a problem statement.*

*You need it for two main reasons:*

- *Your primary research question is a stepping stone from the problem statement. You cannot create the question you will explore if there isn't a problem to solve.*
- *The problem statement gives you focus and makes you hone in on something very particular.*

*Once you have done some research and defined your research problem, you should have an idea of what specifically within the larger problem you want to address. The next step is to turn this into a problem statement that expresses*

the issue you will work to address and demonstrates the applicability of your research. The problem statement need not be one sentence in length. It could also be explained in one brief paragraph.

A good problem statement is based on a thoughtful problem definition and clearly indicates:

1. Where the problem is occurring; and
2. What the problem is.

The statement must also:

- Focus on one problem;
- Be written explicitly; and
- Be relevant

An objective is also necessary. In addition to identifying your problem, you also need to set an objective that will guide your research and justify why it needs to be undertaken.

## **Theoretical/Conceptual Framework**

Your theoretical framework draws support from time-tested theories that embody the findings of many researchers on why and how a particular phenomenon occurs. When your theoretical framework is established, begin to construct your conceptual framework. A conceptual framework represents the researcher's synthesis of literature on how to explain a phenomenon. It maps out

*the actions required in the course of the study given his previous knowledge of other researchers' point of view and his observations on the subject of research.*

*The theoretical framework provides a general representation of relationships between things in a given phenomenon. On the other hand, the conceptual framework embodies the precise course that the research will need to take. Statistically speaking, the conceptual framework describes the relationship between specific variables identified in the study. It also outlines the input, process and output of the whole investigation.*

### **Significance of the Study**

*At this point you should show the significance of your study. Essentially, the section on significance of the study provides information to the reader on how the study will contribute. It must be specifically stated, however, what the study will contribute and who will benefit from it. You can figure out several important contributions of your research paper if you let your mind flow. The following tips may be helpful in writing the significance of the study: 1) Refer to the statement of the problem. Your problem statement can guide you in identifying the specific contribution of your study. You can do this by observing a one-to-one correspondence between the statement of the problem and the significance of the study. 2) Write from general to specific contribution*

*Write the significance of the study by looking into the general contribution of your study, such as its importance to society as a whole, then proceed*

*downwards—towards its contribution to individuals and that may include yourself as a researcher. You start off broadly then taper off gradually to a specific group or person.*

*Coupled with reference to the problem statement, this effectively stimulates the mind to think in a deductive mode, i.e., from general to specific. Toward the end of your Introduction, you should briefly describe the design of your study in such a way that it connects to the justification you've given for the purpose of the study and leads to your hypotheses.*
