

Memo: Hunger Strikes in Detention, a National Trend

Since March of 2020 there have been at least 49 confirmed hunger strikes across the country in facilities that detain immigrants. This is a nationwide trend as people in immigration detention are protesting their incarceration demanding to be released as COVID-19 infections in detention continue to rise. People are bravely speaking out the only way they can — by refusing meals, knowingly weakening their immune systems. These are organized protests to demonstrate the urgent need for people in detention to be released now.

Typical Length of a Hunger Strike

Hunger strikes typically last less than a week, however it is ultimately dependent on the people striking and the level of retaliation they face from agencies like Immigration and Customs Enforcement (ICE) — which often includes abusive treatment, transfers to other detention facilities, deportation, force-feeding and solitary confinement. We have also seen long-term strikes, like the one at the LaSalle Facility in Louisiana by two men who went over 130 days without eating.

Types of Retaliation Strikers Commonly Face from ICE

- Abusive treatment
- Transfers to other detention facilities
- Deportation
- Force-feeding
- Solitary confinement
