- A. **Call to Order** – T. Currier, Vice Chair, called the School Committee Meeting of September 11, 2024, to Order at 7:04pm, in the High School Library.
- B. **Remarks from the Chair** T. Currier remembered the events of 9/11 and spoke regarding the school shooting in Georgia. He thanked the Administration for offering counseling services.
- C. **Public Comment** – Jack, SAB Senior from Boxford, informed the School Committee that Student Council is selling homecoming tickets and representatives are being chosen. The flags were placed at the entrance to the school in remembrance of 9/11.
- D. **Introduction to Kevin Cyr, Director of Teaching and Learning** - M. Harvey introduced Kevin Cyr who comes to Masconomet from Lynnfield. He started at Masconomet July 1, 2024. Kevin informed the School Committee that he spent the summer getting to know the school community and observing. He hopes to formalize Teaching and Learning across the District and will work with the Department Heads to bring the teams together to formalize that work. The School Committee welcomed Kevin to the District.
- E. **Field Trip to the Dominican Republic** - Jeanne O’Hearn presented the field trip to the School Committee. Grades 11 and 12 Spanish will be traveling to the Dominican Republic in April of 2025. 20 students and 2 chaperones will be traveling from Masco and the cost is approximately \$2,950 per student. There will be financial aid available for students. The students will do 3 days of community service which counts towards the Global Diploma Program. C. Bolzan asked if the chaperones would be one male teacher and one female teacher, and she would like it to be a condition of the approval. Discussion followed regarding male and female chaperones and having 2 alternates in place, a male and a female. He reviewed the materials submitted which included the school's plans for 8th grade students in the areas of curriculum, instruction and assessment. M. Harvey recommends approval.
