g) Cyclones (Nicole) -

The U16 Cyclones have picked an extra goalie to go on the trip but the player is an A player. The policy specifically states that they can not have an A or AA player on the team as it is strictly a B team, and any players that are playing A or AA in the current year can not play. The Head Coach was advised today that we can't allow it.
