This page is used to inform visitors of my/our policies regarding the collection, use and disclosure of Personal Information if anyone chooses to use our service. If you choose to use our service, you consent to the collection and use of information regarding this policy.

This Personal Information Privacy Policy ("Policy") applies to all information that the Mobile App may collect about a user during their use of the App.

Use of the Mobile Application (hereinafter "MT") means that the user unconditionally agrees to this Policy and the terms of processing of his/her personal information specified therein; if the user does not agree to these terms, he/she must refrain from using the Services.

1. Personal information of users, which is received and processed by the IG

1.1 For the purposes of this Policy, "personal user information" shall mean:

1.1.1 Personal information is any information that the user provides about himself, including directly the user's personal data. Information which is obligatory for provision of Services (provision of services) is marked in a special way. Other information is provided by the user at his discretion.

1.1.2 Data which is automatically transmitted in the course of their use by the software installed on the user's device, including the IP-address, cookie information, information about the user's browser (or other program with which the Services are accessed), access time, the address of the requested page.

1.2 This Policy applies only to this Application. The IG does not control and is not responsible for the websites and mobile applications of third parties, to which the user can go through the links available in this IG, including in the search results. On such websites and applications other personal information may be collected or requested from the user, as well as other actions may be performed.

1.3 The IP in general does not check the reliability of personal information provided by users and does not control their legal capacity. However the application assumes that the user provides true and sufficient personal information on the issues offered by the IG and keeps this information up to date.

2. Purposes of collection and processing of users' personal information

2.1 The IG collects and stores only those personal data, which are necessary for the provision and provision of services (performance of agreements and contracts with the user).

2.2 Personal information of the user can be used by SE for the following purposes:

2.2.1 To identify the party within the framework of agreements and contracts;

2.2.2 Providing personalized services to the user;

2.2.3 Communicating with the User, including sending notices, requests and information regarding the use of the Services, the provision of services, as well as processing requests and applications from the User;

2.2.4 Improving the quality, convenience of their use, development of services;

3. Terms of processing of the user's personal information and its transfer to third parties

3.1 The IG stores users' personal information in accordance with the internal regulations of particular services.

3.2 Personal information of the user is kept confidential, except for cases of voluntary provision by the user of information about himself/herself for general access to an unlimited number of persons.

3.3 The IG is entitled to transfer the user's personal information to third parties in the following cases:

3.3.1 The user has expressed his consent to such actions;

3.3.2 The transfer is provided by the Russian or other applicable legislation within the procedure established by law;

3.3.3 In order to enable the protection of rights and legitimate interests of the IP or third parties in cases when the user violates the User Agreement of the IP services.

3.4 When processing the personal data of the users the IG is guided by the Federal Law of the Russian Federation "On Personal Data".

4. change of personal information by the user

4.1 The User may at any time change (update, supplement) the provided personal information or its part, as well as the parameters of its confidentiality.

5. Measures, used for protection of personal information of users

5.1 The IG takes necessary and sufficient organizational and technical measures to protect personal information of the User from unauthorized or accidental access, destruction, change, blocking, copying, distribution, as well as from other unlawful actions of third parties with it.

6. Changes in Privacy Policy. Applicable Law

6.1 The IG has the right to make changes to this Privacy Policy. When making changes in the current edition, the date of the last update is indicated. New version of the Policy comes into force from the moment of its posting, unless otherwise provided by the new version of the Policy.

6.2 The law of the Russian Federation shall apply to this Policy and the relationship between the user and the IG, arising in connection with the application of the Privacy Policy.

7. Changes in this Privacy Policy
