**The ideal candidate will possess expertise in the development and implementation of grant-funded initiatives with emphasis on youth behavioral health, community outreach, diverse stakeholder engagement, workforce development (i.e. training & education), and substance use prevention. They must demonstrate strong project management skills.**

### **Primary Responsibilities**

Manages and oversees the grant-funded program lifecycle (from planning of grant activities to development of deliverables and execution/implementation across GA).

This will include, but is not limited to:

- Coordinating multi-pronged outreach to diverse identified stakeholders (youth, caregivers, and youth-serving adults).
- Facilitating engagement activities including regional partnership collaboratives, outreach events, and community-based trainings.
- Presenting regular status reports + dashboards to CWC Alliance & Resilient GA executive leadership (i.e. CEO, COO, Executive Director) and key identified partners.
- Delivering detailed project plan, stakeholder engagement registry, outreach/communication plan, separate curricula tailored to youth & youth-serving adults, executive dashboard, and reporting as required by the grant.
