

# Privacy Policy for Tic Tac Toe Double

This Privacy Policy describes how [Your Developer Name] ("we," "us," or "our") handles information in connection with your use of the Tic Tac Toe Double mobile application (the "Service").

**a) Personally Identifiable Information:** We do not collect any personally identifiable information (PII) from you. The game can be played entirely offline and does not require you to create an account, sign in, or provide any personal data such as your name, email address, phone number, or physical address.

**b) Non-Personally Identifiable Information (Collected by Third-Party Services):** While we do not collect data ourselves, our app integrates third-party services that may collect information to provide their services. The primary third-party service we use is Google AdMob.

## 2. How We Use Your Information

Since we do not collect your personal information, we do not use it for any purpose. The information collected by our third-party partners is used for the following purposes:

- **To serve advertisements:** Our app is supported by ads provided by Google AdMob. AdMob may use the data it collects to show you personalized or non-personalized ads.
- **To improve their services:** This data helps our partners maintain and improve their ad services, such as by capping the frequency of ads, combating fraud, and providing aggregated reporting to advertisers.
- **To provide a better user experience:** For example, rewarded ads allow you to access features like ad-free time or hard AI mode in exchange for watching an ad.

## 3. Third-Party Services: Google AdMob

We use Google AdMob to display advertisements within Tic Tac Toe Double, which helps us keep the game free. AdMob is an advertising service provided by Google Inc.

AdMob may collect and use data about you, such as your device's advertising ID, IP address, device information (e.g., operating system, device model), and information about your

interactions with ads shown in our app. This is done to provide you with more relevant advertising.
