- 4th Grade Farewell update
- Talent Show update, is June 24th; 7pm with deadlines discussed
- Mrs. Burfeind spoke about the VV Spring Bookfair that went very well. \$9,500 in books sold, ½ back in scholastic dollars. Can get library bound books for the library as well. In the fall book fair, all of the money from scholastic is divided between all the instructional specialists at VV. The spring book fair all profit goes to the library. Looking forward to Fall 2022 Bookfair hopefully Scholastic will have more in stock available and they can do a 3rd Book fair in 2023, which is Buy on Get one Free.
- --- Cultural arts update by Mrs. Burfeind: VV had fundamentals of Hip Hop, Principles of Hip Hop and History of Hip Hop in April. Project Duo "outside the bachs" was postponed due to COVID. Next week Catskill Puppet Theater has 2 performances on June 8th for K-2 and 3-4th grade.
