### **Dog Registration**

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$30.00 USD. You may register your dog online at <http://nasda.dog/registration>

### **Awards:**

Awards will be handed out at the conclusion of the trial each day. Ribbons are awarded for qualifying scores, Best of Breed, and High in Class. New Title Ribbons will be awarded upon request.

### **Venue:**

Exhibitors can crate in their vehicles or set up shade tents and crating in the designated crating area. TBASCO and the owners of Tucker Creek reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. There will be water available for dogs on site as well.

### **Notice to Exhibitors:**

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date unless there is a wait list that can fill spots.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.

- All dogs must be on leash at all times except when competing as applicable.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog. Please make sure to potty your dog prior to running your dog
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$50 fee for any returned check or payment. Checks must be made payable to TBASCO.
- TBASCO reserves the right to refuse any entry without cause or explanation.
- A schedule of classes and events will be sent out up to one week prior to the trial.
- Friday trials begin at 6:00 PM. Handlers briefing will be at 6:00pm and first dog will start Immediately after
