- b. Steve Shiever ZOOM meeting with Ben Bush and Jerry Hobbs to discuss UV lighting

Mr. Shiever introduced Mr. Bush, a distributor of UV Angel, and Mr. Hobbs, who has 30 years of service as school administration. Steve stated to the Board that there is a FEMA grant available to cover the costs for air purifiers. The grant pays 50% up front, then the school district pays the other 50% to be reimbursed by FEMA after completion. These light fixtures are used at Anthony Anderson and St Jude for clean air solutions. A 2'x4' light panel is installed, containing both LED and UV lights. Each one cleans and circulates about 1,500 cubic feet of air. Per minute, each unit clean 50 cubic feet of air and eliminates 80 pathogens. No chemicals are used, and fixtures can be on while the room is occupied. Fixtures have a low noise level, roughly 30-40 decibels per unit and can be accessed by a Cloud App. Filters and lights have a life expectancy of 3-6 years. Each fixture comes with a 5-year warranty.
