

TERMS OF USE & COMMERCIAL LICENSE AGREEMENT

The following terms of use & commercial license agreement (the “Terms of Use”) constitute a binding agreement between you and Mong Shoo.LTD, with respect to your use of our subscription plans, 3D models, digital designs, and related products (collectively, the “Offerings”). BY ACCESSING OR USING THE OFFERINGS, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTAND, AND AGREE TO THESE TERMS OF USE.

If you do not agree to these Terms of Use, do not use or subscribe to the Offerings.

1. Commercial License Terms & Validity

Subject to these Terms of Use and your active subscription status, Mong Shoo.LTD grants you a limited, revocable, non-exclusive license to 3D print and sell physical copies of our models .

To maintain this Commercial License, you must strictly adhere to the following conditions:

- **Active Subscription Requirement: Your commercial license to sell physical prints is strictly valid only while your subscription remains active and fully paid.**
- **License Expiration: The moment your membership access ends, cancels, or lapses due to non-payment, your commercial license expires immediately. You must cease advertising, displaying, and selling any physical products derived from Mong Shoo.LTD files.**
- **Production Limit: Under the standard commercial tier, you are strictly limited to producing and selling the maximum number of physical copies specified by your tier, per model, per month. Producing quantities beyond this limit requires an upgrade to a higher-tier subscription.**

2. Production & Sales Limitations

- **No Digital Sales or Sharing:** You may not share, distribute, alter, or sell the digital files (STLs, 3MFs, etc.) under any circumstances. You are only permitted to sell the physically printed 3D objects.
- **Output Format:** This license applies strictly to 3D-printed physical objects.

3. Prohibited Uses & Strict Restrictions

The following actions are strictly prohibited and constitute a material breach of this agreement:

- **No Digital Distribution:** You may not share, sub-license, rent, alter, remix, or sell the digital files (STLs) or any modified digital variants under any circumstances.
- **No Mass Production:** Industrial mass production, injection molding, or creating molds for resin/silicon casting of the models is strictly prohibited.
- **No Third-Party Dropshipping:** You are prohibited from manufacturing or selling products through third-party platforms, manufacturers, or fulfillment services. Selling through entities such as TEMU, Alibaba, AliExpress, or similar dropshipping marketplaces is strictly forbidden. All physical prints must be produced directly by the license holder.

4. Termination & Remedies

- **Mong Shoo.LTD** reserves the right to monitor compliance, audit store listings, and terminate subscription access without a refund if a breach is detected. Unauthorized commercial use after license expiration or digital file leaking will be subject to copyright infringement claims and legal remedies under applicable intellectual property laws.

5. Ownership and Intellectual Property

- **All Offerings**, including but not limited to 3D models, character designs, graphics, and digital files, are solely owned by **Mong Shoo.LTD** and are protected under applicable copyright and intellectual property laws. **Mong Shoo.LTD** does not grant any express or implied right to you under any patents, registered designs, copyrights, or trade secret information beyond the limited physical printing license described herein.

6. Violations, Takedowns, and Termination

Mong Shoo.LTD has the right to deny access to, and to suspend or terminate your access to, the Offerings at any time if you violate these Terms of Use.

- **Enforcement of Limits:** If you exceed the copy physical production limit without upgrading your tier, or if you violate the mass production/digital file sharing rules, it will be treated as a severe copyright infringement.
- **Platform Reporting:** Mong Shoo.LTD actively monitors e-commerce platforms (such as Etsy, Amazon, Smart Store, etc.). Violating these terms will result in an immediate ban, revocation of your license, and the issuance of formal DMCA take-down notices to the platforms hosting your infringing listings. Upon suspension or termination, you must immediately stop selling all models.

7. Disclaimer and Limitation of Liability ("AS IS" Basis)

- **All Offerings, digital files, and models are provided on an "AS IS" and "AS AVAILABLE" basis without warranties of any kind. Mong Shoo.LTD is not responsible for any file errors, printing failures, physical injuries, or financial losses resulting from the use, 3D printing, or commercial sale of these products. You assume all risks and liabilities associated with manufacturing and selling the physical items.**
- **"Mong Shoo.LTD makes no representations or warranties regarding the food safety or structural safety of the printed objects. Users are solely responsible for ensuring the materials and final products are safe for their intended use."**

8. Ownership of Modifications

- **Mong Shoo.LTD retains 100% sole and exclusive copyright ownership of all original designs and digital files. In the event you alter, remix, or modify our models in any way before printing and selling them, you agree that Mong Shoo.LTD remains the sole copyright owner of both the original and the modified versions. You may not claim intellectual property rights over any altered designs.**

9. Age Restriction

- **You must be at least 18 years of age (or have reached the age of majority in your jurisdiction) to subscribe to our plans and use the Offerings. If you are under 18, you must have explicit permission from a parent or legal guardian who agrees to be bound by these Terms of Use on your behalf.**

10. Changes to Terms and Governing Law

These Terms shall be governed by and construed in accordance with the laws of the Republic of Korea (South Korea).
