

CIMUN XXII Awards Policy July 21, 2025 John Salchak

At CIMUN, we believe the core value of Model United Nations lies in the educational experience it offers—through diplomatic engagement, public speaking, and policy simulation. Awards, while secondary to these outcomes, play an important role for many schools and students who invest significant effort in preparing for our conference. Our awards policy reflects CIMUN's values of accuracy in representation, engagement within and across committees, and a commitment to fairness for all schools, regardless of size.

We recognize that delegation awards can influence how schools structure their teams. Our goal is to increase transparency and incentivize strategies that enrich the conference experience for all. CIMUN is proud of the educational experience we provide, and we encourage schools to bring as many students as they are able to support. Our awards system is designed to reward excellence without discouraging inclusivity.

Individual Delegate Awards:

Individual delegates and delegations, in the case of CIMUN's double-delegate committees, are eligible for awards based on in-committee performance. Awards are distributed in each committee in proportion to its size. A full chart of CIMUN XXII's awards can be found later in this document. The following distinctions may be awarded:

- Best Delegate or Delegation: 3 points
- Outstanding Delegate or Delegation: 2 points
- Honorable Mention: 1 point
- Delegate's Choice: 2 points (selected by fellow delegates)

To encourage participation in CIMUN's most advanced committees, awards multipliers will be in effect for individual delegate and delegation awards in select bodies:

- UN Security Council: 2x points
- Ad-Hoc: 2x Points

In addition to our in-committee awards, CIMUN rewards exceptional cross-conference performance through conference-wide awards for individual delegates:

- Simulations Award: 3 points awarded to two delegates for cohesive and creative cross-committee engagement.
- Position Paper Award: 2 points awarded to 3 delegates for exceptional research and rhetorical skill in their pre-submitted black papers, and 3 for their pre-submitted white papers.
- GA Plenary Award: 3 points awarded to one national General Assembly delegation (DISEC, SOCHUM, and SPECPOL delegates) for their joint performance in the General Assembly Plenary Session.
- ICJ Advocate Award: 2 points awarded to one delegate for exceptional advocacy in the International Court of Justice. Only delegates who argue a case before the International Court of Justice are eligible.

Delegation Awards Structure

We offer three categories of delegation awards, allowing both large and small schools to be recognized:

- 1. National Delegation Distinction: Awarded to the top performing country, based on both total points earned divided by the number of positions held, in addition to demonstrated collaboration between members of a national delegation to advance their country's shared goals across CIMUN's different committees and cabinets. Empty positions for a country will still count for the denominator in this award.
- 2. School-Based Best Delegation Awards: Schools are categorized into Large and Small Delegation Divisions, with the cutoff determined by median delegation size at the start of conference. Awards are based on the average number of points per delegate to ensure fairness across team sizes.
 - a. This approach is intended to reward both breadth and depth: large schools are marginally penalized for expanding delegation size for inclusivity, and small schools can remain competitive with strong performance.

3. CIMUN Grand Delegation Award

a. This is awarded to the school with the highest total point accumulation regardless of delegation size or division. This is intended to recognize strength at scale.
