By commissioning me or buying a design from me, you are stating that you have read and agreed to these terms.

This TOS may be subject to change at any time without notice.

BASICS:

- Payment comes first. PayPal only.
- My artwork and designs are for **personal use** only. Anything regarding this has to be discussed with me directly.
- Commissioner can re-upload the image with credits given to myself in the form of a **link** to my DeviantArt, Instagram, or my Toyhou.se account.
- I reserve **the right to refuse** any commission at any time, for any reason and without explanation. A refund will be issued if for any reason I am not able to continue working on your commission.
- I do **not** allow my art to be used for NFTs, or for AI.

REFUNDS:

- **No refunds** after the commission has been already **been done**, **or nearly completed commissions**.
- I **reserve the right** to **refuse** any commission at any time. A **refund** will be issued if for any reason I am not able to/am uncomfortable working on your commission.

Designs/Adoptables/Adopts

BASICS:

- I **own the rights** to the drawings I made of the adopt. I'm free to use my art and post it so future clients will be able to see them.
- I will never claim the character as my own, but you are obliged to credit me for the

design at least once somewhere visible, if you upload the character to another website.

RESELLING, TRADING AND MODIFYING:

- You're allowed to gift, sell or trade my designs, with the condition of no trading or selling for more than it's total value. Most of my recent designs have their initial value stated in their Toyhou.se profile ownership log, or you can ask directly to me what was the original value if that information is missing.
- In case of characters that weren't bought in a proper way, such as chargeback, the design's rights and ownership are not legitimate, therefore their **ownership** goes back to me.
- THOSE WITH TOYHOUSE: Do **not** delete my characters from Toyhou.se. You're free to **hide** them, but I will know if they have been deleted from the site. If I know you have been deleting one or more designs from the site I can stop doing business with you; alternatively if you own a design that didn't originally had a Toyhou.se profile, or you're the new owner of a design which it's profile has been deleted, you may provide proof of purchase/trade/gift to me in order to give official design credits on the site.
- You may change small things on the design such as color and a few patterns. The final product must **resemble** the original. If you do change the design and think it may be too much please contact me first for approval.

REFUNDS:

- Once you accept and the payment goes through, **refunds are not** accepted.

BLACKLIST/GREYLIST:

- Breaking these terms, not answering on time several times, and having a public record of poor behavior will result in either getting on my personal Greylist or

Blacklist.

- Those who are in my **Greylist** can still do business with me but I will be wary.
 - Those who are in my **Blacklist** are banned from doing business with me.
