TERMS AND CONDITIONS OF SERVICE

1. The Stud Service Fee shall be \$2,700.00 or the price of puppy from produced litter, whichever is greater.
2. Payment for stud services is to be paid 50% at the time of breeding. The remaining 50% of the stud service fee is due with the AKC/NAVHDA registration paperwork sent to the stud dog owner to fill out after litter is born (3 weeks after whelp date). Any other arrangements must be specified in the initial agreements for the breeding, (i.e. In lieu of the stud fee, the owner of the stud dog shall be afforded "Pick-of-the-Litter"). In the event that the owner of the stud dog chooses to take a puppy in lieu of a stud fee, the owner of the stud dog reserves the right to withhold the signing of the AKC litter registration until said puppy is in the possession of the stud dog owner.
3. A "Live" litter is guaranteed. Three live puppies whelped is considered a live litter. Additionally, if the bitch fails to whelp, the owner of the bitch must notify the stud dog owner within ten (10) days of the whelping due date. If less than three puppies are whelped or the bitch fails to whelp, one return use of the stud dog described above to the bitch described above shall be provided. The bitch's owner(s) shall pay any additional expenses (i.e. artificial insemination) required for the second attempt at breeding.

4. All expenses, including but not limited to: transportation, veterinary care, emergency service, and feed are the responsibilities of the owner(s) of the bitch. We do not offer boarding service for breeding bitch at our facility.
5. The owner of the stud dog shall maintain reasonable care of the bitch while at the stud dog owner's facility. The bitch's owner will maintain reasonable care of the stud dog while at the facility of the bitch's owner.
6. If this breeding is to be consummated through a live tie, fresh artificial insemination (AI) will be administered, only if necessary, with any expenses incurred being charged to the owner of the bitch. Mating will take place at the stud dog owner's facility unless otherwise arranged.
7. Any bitch found unsuitable for breeding or cannot be bred due to viciousness or any other extreme behavior problem will be returned to the owner of record or agent immediately along with the stud fee, minus documented expenses incurred.
8. It is the responsibility of the owner(s) of the bitch to advise the owner of the stud dog of any habits, behavioral problems, medical conditions or special needs of the bitch described above.
9. The owner(s) of the bitch shall furnish the owner of the stud dog the following information prior to breeding:
 - a. Current immunization records
 - b. Negative Brucellosis test (performed no more than 3 weeks prior to breeding)
 - c. Copy of AKC registration papers and pedigree
 - d. Inter-State transfer certificate (if applicable)
10. The bitch owner will supply a completely filled out Litter registration form to the stud dog owner within 3 weeks of whelping. The stud dog owner will complete and sign the form and either return it to the bitch owner or send it on to AKC for processing. (Bitch owner will provide the funds for litter registration)
11. No changes or modifications to the terms of this contract shall be made unless reduced to writing and signed and dated by the owner of the stud dog and the owner of the bitch described above.
