Executive Summary

Karma Global Education (KGE) and the KGE Foundation form a hybrid social enterprise linking education technology, student advocacy, and social impact.

Mission: To transform every study-abroad journey into a pathway of empowerment, connection, and contribution.

The Opportunity

Over 70,000 Nepali students study abroad each year, but few return to invest skills or capital.

KGE integrates ethical admissions, advocacy services, a transparent SaaS platform, and Foundation reinvestment.

Business Model Overview

Revenue from commissions, subscriptions, training, and donor funding. Up to 35% of profits reinvested in the Foundation.

Advocacy Delivery → Student Support via KarmaConnect Hub

Technology Enablement → Shared portals for transparency

Current Status & Traction

Beta ready with 24 Airtable tables, 3 portals, 3 pilot partners, and Impact Dashboard prototype.

Soft Launch: January 2026 | Year 1 Targets: 100 students, 10 consultancies, 5 universities.

FY2026 Revenue: \$120,000 | FY2027: \$350,000 | FY2028: \$700,000.

Reinvested Profit: $\$25,000 \rightarrow \$175,000$ projected by 2028.

Investment Ask

Total Raise: USD 200,000 for 2026.

Options: 5–10% equity, convertible note, or philanthropic grant to Foundation.
