#### 1. Context and meeting called to order

For obvious pandemic reasons, the Annual General Meeting (AGM) could not take place in October 2020. In early December 2020, SNC-Lavalin sent, by mail, to active and non-active participants, a notice of meeting of the Participants Annual Meeting (PAM) of the pension plan for managers and employees of SNC-Lavalin Group inc. In this same correspondence, there was the invitation from Mario GERVAIS, president of the Retiree's Association, which included the agenda, in both languages, to attend the annual general meeting. An email reminder on January 17, 2021 was sent to members whose email address is known to the Association. Finally, Ms. Line Laperle of SNC-Lavalin HR sent to those who showed their presence at the PAM and the AGM, the documents relevant to the conduct of the two meetings.

The meeting is therefore taking place today, February 11, 2021 on a digital platform.

After some minor connection difficulties, the meeting begins at 3:10 p.m.

#### 2. Appointment of the Chairman and Secretary of the meeting

The President announces that in accordance with the Association's customary practices, the current President, Mario GERVAIS, and the Secretary, Ramy K. LOUIS, would act as Chairman and Secretary of the meeting. A tacit agreement of the members followed

#### 3. Verification of the Quorum

#### 4. Approval of the agenda

#### 5. Reading and approval of the minutes of the annual meeting of October 10, 2019

#### 6. President's report

#### 8.2 Association's website - Ivan LAMOUREUX

Ivan LAMOUREUX explained the difficulties he had with the Association's website following the changes made by Google and he hopes to be able to update the site soon.

#### 10.1 Treasurer's report – Francine LAVALLÉE

The treasurer submits her report for the financial year from October 1, 2019 to September 30, 2020. A copy of the treasury report on the comparative financial statements 2018/2019 and 2019/2020 can be found in appendix 3 attached.

Actual disbursements as of September 30, 2020 amount to \$2,943.12, and revenues are \$4,065.25 of which \$3,000 comes from SNC-Lavalin and \$1,065.25 is carried forward from the fiscal previous year. For comparison purposes, the figures for the previous year with the relevant details are shown in the cash flow report, vis-à-vis those for the 2019-2020 financial year.

#### 10.2 Secretary's report – Ramy K. LOUIS

The secretary informs the members present of the number of meetings of the Board of Directors that have taken place since October 10, 2019, the date of the last annual general meeting to date, i.e., 8 meetings. He specified that since May 2020 the meetings have been taking place using the ZOOM application and thanked Ivan LAMOUREUX for his support in organizing these meetings.

He announces the transmission in French and English version of the agenda of this meeting as well as the minutes of the 2019 AGM to the members whose email address is known by the Association. He took the opportunity to thank René CHAMPOUX for all these years at the service of the Association and welcomed Francine LAVALLÉE for her role as treasurer within the Association. He takes this opportunity to thank the SNC-Lavalin Corporate Human Resources team for their usual cooperation and Ivan LAMOUREUX for his dedication to monitoring the website.

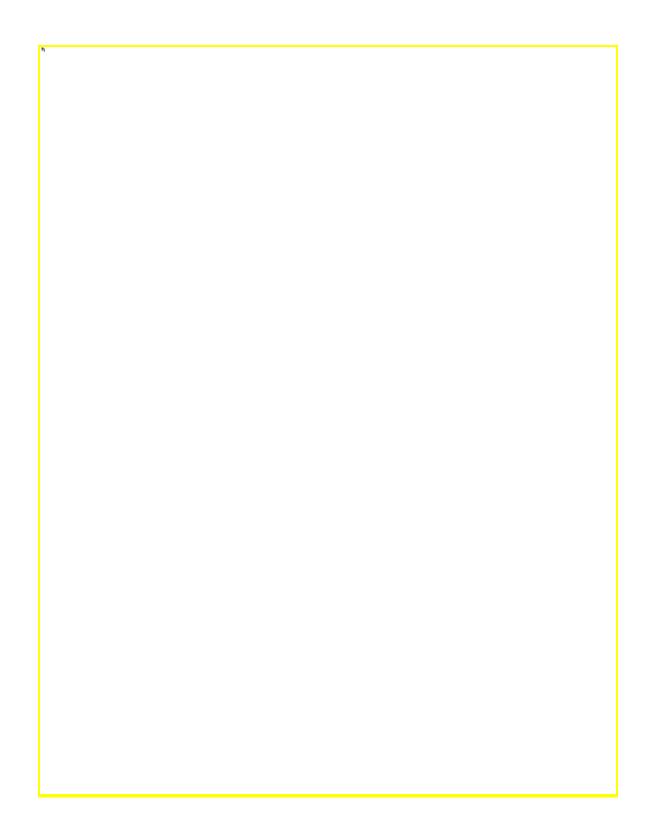
