7. Additional terms and conditions:
  - a. The Promoter will pay for all production costs for production, including but not limited to, front-of-house sound and monitoring, live engineer, stagehands, lighting and backline, as mutually agreed in advance by the Promoter and Artist..
  - b. Stage lights to current safety standards are to be provided by the Promoter.
  - c. The stage area must be secure and no less than 16' deep by 20'.
  - d. The Venue is to provide a secure, clean, A/C dressing room, with 6 towels and five pitchers of ice water and glasses in the green room, prior to the Performance.
  - e. Artist and wives (if attending) will have free admission, plus a table for dinner if applicable.
  - f. During the Performance, Artist Production Manager has final authority over the artist live sound mix, and will work in coordination with the Venue production team.
  - g. Audio Recording or Commercial Visual Recording/Photography is permitted for non-commercial use. Artist reserves the exclusive rights to all filmed and recorded content.
  - h. The agreement of musicians to perform is subject to proven detention by sickness, accidents, riots, terrorist actions, strikes, acts of God, or any other legitimate conditions beyond their control.
  - i. If for any reason the Promoter cancels the performance Artist a cancellation fee of 50% cash is pre-agreed damages..
  - j. In the event of any damages or injury sustained by the Artist during the performance resulting from Promoter gross negligence, payments will be first paid by Promoter liability insurance policy.
  - k. This agreement shall remain confidential between the Artist and the Promoter.
