Abstract

The abstract must be able to explain briefly, concisely, and clearly about the chosen theme and can represent the article's content. The abstract must stand alone, and there are no citations in it. Avoid using unusual abbreviations and inappropriate jargon. Abstract written in Indonesian, Open sans 8pt, italics, left-aligned, 1 space, consisting of 200 words, contains the background of the problem, urgency/purpose of writing, research methods (for research articles), and research results or conclusions. A keyword is a clue from an article you write to correct in indexing and as a search clue. Therefore, keywords should represent the content and highlights in your essay.

1. Introduction *(the arrangement of subchapters should not be changed and supplemented; Open Sans 12 PT, Capitalize Each Word)*

Introduction Section: the author must state the purpose of the research at the end of the introductory part. The author must write an adequate background, research objectives, research problems, and a brief literature study. The author must be able to demonstrate the recency of the research conducted in addition to the limitations of previous studies. In this section, the author must include at least 15 research results that are themed a maximum of the last 5-10 years and show the latest aspects of the research the author conducted. The introduction should also offer the scientific benefits and novelties of the research carried out *(Open Sans 11 PT, Capitalize Each Word)*

2. Data and methods *(Open Sans 12 PT, Capitalize Each Word)*

2.1 Subtitles *(subtitles can be added; Open Sans 11 PT, Capitalize Each Word)*

In this section, the author can explain the methods used to achieve the research objectives. Explanations can be through diagrams or text flows to describe the research stages.

The author must cite every citation in the form of data and statements sourced from secondary sources or other libraries. If the information is sourced from one person, then the citation format is to include the author's name and year (Example: Sugiyono, 2015). If the author consists of two people, the citation writing becomes the name of author 1 & author 2, year (Example: Khairullah & Cahyadin, 2016). If the author consists of more than two people, then only the name of the author is written first and followed by "et al." or "et al.", year (Example: Mavhura et al., 2013). All references used in writing articles must be included in the Bibliography. Vice versa, everything written in the Bibliography must be referenced in the text. The images are presented sequentially with the image title and numbers below the image, as shown in the example of Figure 1. *(Open sans 11pt)*





Figure 2. District Map

3. Results and Discussion *(Open Sans 12 PT, Capitalize Each Word)*

3.1. Subtitles *(Open Sans 11 PT, Capitalize Each Word)*

This section presents the data obtained, data analysis, specific findings and comparisons with previous studies sequentially according to the order of the objectives. The discussion should contain:

1. What are the findings of the study
2. What did the findings mean?
3. Compare the findings with the results of previous research (state-of-the-art)
4. What are the implications of the findings?

Avoid presenting tables and figures from the same data. Here's an example of a table rendering format.

4. Conclusion

- Conclusions must refer to the purpose of the study and contain findings of research results in general instead of repeating abstracts.
- Made in 1 paragraph and focused on answering the research objectives
- The conclusion is not a list of results
