List of Affirmative Communication Actions

- I respect the anonymity of others by not using a member's last name in the text of a message.
- If a member's last name appears in an e-mail address, or if the member is identifiable in any way, I will remove that address in any carbon copies unless I have the member's permission to send it as is.
- I obtain permission before faxing CoDA identified materials to a member.
- I respect the personal integrity, anonymity, and privacy of each member, and I expect and deserve the same.
- I maintain civility and decorum in my communications to members of CoDA, as I practice developing and maintaining healthy relationships. I continue to practice healthy interpersonal behavior in communications via telephone, fax, e-mail, and the Internet.
- When in doubt about the content or intent of a letter, telephone call, e-mail, or other communication, I first request clarification from the author before discussing its content.

- When I participate in a group discussion (in person or by Postal Service, telephone, fax or e-mail), I maintain focus on the subject at hand. My attention and focus is a gift I offer other members.
- Recovery is a process; I respect each member for where that member is in recovery. I practice my program by sharing my experience, strength, and hope with others, not by pointing out faults and flaws in others.
- The text of any forwarded message is transmitted verbatim. I do not edit it. (For the purposes of committee work where editing work is in process, I clearly mark a previous, unedited version and include it with my suggested revisions.) Generally, emails are not forwarded to people not addressed by the original sender.
- I encourage others in their recovery, and do not "flame" them. Flaming is a written attack on a person, a person's opinions, or a person's point of view, distributed to multiple addresses, usually via e-mail. When my opinions differ from another, I share my experiences with that person, explaining how they are different or similar.
- When sending email to a list of addresses, I send the message to myself and use BCC (Blind Carbon Copy) for the list of intended recipients in order to protect the anonymity of the members.

Virtual Office Guidelines

 - a. The updating and publication of the LA CoDA meeting list,
 - b. Updating of the LA CoDA Mailing and phone-contact computer database,
 - c. Updating of the LA CoDA Meeting Information Line computer phone system
- Cooperates with the Historian Sub-Committee in the storage and accessibility of historical data and documents including LACC Guidelines, LACC minutes, CoDA meeting lists, other CoDA Community Committee minutes and various other documents.
- Cooperates with the Literature Sub-Committee in the storage and distribution of digital CoDA literature, CoDA pamphlets, meeting start-up kits, and other CoDA-endorsed literature
- 7. Manages its current sub-committee budget and submits a new budget for the next year.

My second sponsor added that, to them, being of service means never being depleted. If they're depleted emotionally, financially, physically etc, they're not really being of service, they're numbing a feeling. This gave me a much-needed way to check in with myself and explore saying no.

As I moved through the CoDA program, I found I began to do service because I wanted to, not because I needed to, and my want came from a free place, not from fear or from endlessly needing reassurance that I'm a good person.

I truly receive when I give from this state-of-heart, and usually without guilt.

I have the ability to say no now, even if I have the time to help. The cycle of over yes-ing, until I get sick or hurt and then isolating to recuperate, is mostly an old memory.

I've felt what it is to not help compulsively and learn I'm still safe, loving and loved. I've experienced leaving space open for the unknown, accidentally creating room for intimacy with my life. To me, the words 'recovery' and 'service' have new meaning.

Because it's a renewal of a domain and not a new domain, the price doesn't go down with more years purchased. If it were brand new, then could get a discount as we maximized # of years purchased. Reason is: it depends on .org extension. GoDaddy is a registrAR (they sell the .org) not a registry (they own the .org & decide it costs more than .com or others), so GoDaddy doesn't decide that it costs more, the registry does. So it's good to buy many years all at once to keep rate the same. If we auto-renew each year, the domain cost would be at market rate at the point it auto-renews- every year it could go up.
