Issue Statement

The COVID-19 Crisis has exposed the reality of food insecurity for many in our community and the shutdown of tourism has completely altered food distribution channels. How can we increase local food production and create job pathways in the agriculture and food service sectors with the future of tourism so uncertain.

<u>Proposal #1: 'Ike 'Ai Consortium on Sustainable Food Systems: Transforming Hawai'i's Food Systems Together</u>
Albie Miles (UHWO) and Kamuela Enos (UHM formerly MAO)

Background

- Born out of years and generations of aloha 'āina
- There are lot of barriers to scaling local food production
- Supported by KS, LT, Ma'o Organic Farms, etc.
- Distinction between ag and food systems work
- Reference document: https://www.civilbeat.org/2020/04/if-we-get-food-right-we-get-everything-right/
- At UH, there's no center for food systems, where there is a place to work on sustainable food systems (research, policy, etc.)

<u>Proposal</u>: We need to have someone to coordinate all of the work that is happening with food systems and have an empirical study to determine food system vulnerability.

- Convening diverse stakeholders for applied research, policy analysis
- Positioning center for good food purchasing, institutional purchasing
- Survey tourism industry for how we can capture and keep funding in Hawai'i
- Invest, scale, adapt
- Part of future crisis response (ex., COVID)
- How do we convene the right experts to solve these problems and get the political will to provide the right input around our food systems in Hawaii?

Proposal #2: Should we support a proposal to strengthen Hawai'i's farm to school movement by supporting regional and statewide coordination and programming?

We need systems change in agriculture and health

Dexter: How can regionalize procurement and look at regional needs

Needs assessment on Kauai = more sourced from kauai farms and better prices

Lydi: Statewide strategic planning for farm to school; rooted in community input, wisdom, decision making

Davis: Acknowledge Tammy Hoe Smith - NH charter schools school lunch. Local produce, hawaiian food staples 20 years.

Tammy: need is great, work is tough. Must be done. Cannot wait for the system. How do we come up with our own answers when decision makers are unable to find the solutions? We need systems that respond to the communities they are serving, not just one size fits all.

DOE will be soliciting programs for the harvest program as well as pork and beef.

Partnerships have been huge. Working with the KS land assets team has been huge. What can the DOE do to "sweeten the deal" for farmers?

DOE launched a beef deal and now that they are doing the second one, it should be much better. How can we work together to do things better.

Any quick takeaways or last mana'o people want to share?

- Walter: We've been talking about 'aina momona and 'āina aloha for so many years, and it's gone nowhere.
 I see a light shining through this pandemic mess. While everything is on pause, this is the time to act. AAEF has given a platform to build on and we need to get past the talking and start talking about some of these things.
- Tammy: easy to just keep blaming others. Let's just figure out what we going to, how we going do 'em, and let's just do it. We can always say that KS can do better, but it's not a KS problem, it's an US problem. Make sure everyone votes and let's make changes. Let's start being the solutions
- Kalani Bright: Would be wonderful to have legislation to prefer local produce over imported...both in grocery stores, restaurants, and schools while also having land considerations given to farmers from state, organizations, and institutions. How do we reduce the stranglehold the US Continent has over Hawai'i with regards to importing Hawaiian foods. Fruit flys or really just a competition California and other states dont want. How do we change that power narrative. What ways can the state, departments, counties, and big organizations listen and help our farmers/producers? And how do we give farmers a regular respected voice into gov't. Advocacy and voice and media attention to this issue is important; people feel the food issues.

- Davis: Plan that was put together by KUA and is really about investing in an 'āina workforce. With the
 CARES act monies coming down the pipe, we need to move in unison to demand that those workforce
 training funds go toward 'āina management and restoration jobs. For the policy makers, please advocate
 for our 'āina based organizations to get funding. Advocate hat, "COMMUNITY, WE GOT TO MOVE."
- Walter: We need a conservation core to take all of this money and get it all done.

Where are we going for Step 4?

- All the mana'o will get wrapped up into some type of report that we can take out to our communities to advocate. Let's take this to the private sector, the government, and beyond. The kuleana is ours. We have to hold ourselves accountable, the lawmakers accountable, and even the private sector accountable.
- We are hoping that we will have a tool that can be taken away to share and advocate. Building a collective voice around all of these individual sectors and all that comes with it.

It is a collective effort and we all need to focus on how we all need to do better. Born and raised in mauka Kona, for us as consumers, we as the public, need to change the culture. How do we change our palette and our preference for local foods? How do we change our marketing and branding? Does KS need to pull it's weight? Absolutely. We all have to work together to do this together to change the culture of food in Hawaii. Not changing it, going back to what our community and our people knew. |

| Walter: What are some of the problems with the fish hatcheries (Proposal #3) | Maria: Legal problems (in the past, one DOH problem made it really difficult to grow) Unless you have a fishpond, you can't grow fish because you can't take water from the sea We need to look at culture systems and there are dozens of systems we could use. Katie Kamelamela (from chat): Shellfish hatchery w NELHA is a HUGE industry supplying 70% of oyster farms in US w seed. The oyster seed industry is like the queen bee industry in the islands where if Hawaii stops producing the US industry can collapse. Policy barriers to growing shellfish. There is also a barrier to selling shellfish grown in US outside to Europe and other countries. This puts |

strain on potential markets. It's important to understand the centrality of Hawaii to the nationwide market for oyster.

Maria: Even before we try to supply more to the mainland, how can we produce for Hawaii? Working with fishponds since 2009--specific to shellfish. There are lots of issues with water quality.

Walter: We need to have a really good plan to figure this out. Let's use COVID to figure out what we need to do and move. Food is the number one issue so now is the time for us to push food. Let's reboot that whole thing and figure out how we put hihiwai back in our rivers and mullet back in our fishponds. There's a lot of hope, we just need to organize ourselves to produce more food. These are the kinds of things we need to create jobs for.

Danny Bishop: Maybe lobbyists are the way to go to persuade people to change the policy.

Policy makers: what are some of the immediate actions that you see happening that the community could support?

Keani rawlins molokai

Establish maui county dept of agriculture
We need more of an advocate for our ag community:
farmers, meat producers, aquaculturalists
Centralize in one department and use this office to
help navigate the different state and federal
regulations. Should be on the ballot in November.
Preserving ag land in Maui County and helping to
ease some of the tax burdens. Formed a TIG to
ease the burden for property taxes and fees for ag
land. Also, investing more into ag. This year, we
invested \$2.5 million in small grants in our ag
communities. Put our money where our mouth is.

Amy Perruso - Maui: adjourned for the session--there have been presentations lydi presented to the house committee and there is a lot of interest in food systems. We may see some movement this session depending on the outcomes of this election. Could see some big shifts.

Mason Chock - Kauai: leveraging the CARES act funds to support things that are moving. Some things we are supporting are Aina hookupu o Kilauea, food innovation center with Common Grounds. Local farmers are where we are expanding our efforts. Also, how do we partner with our local restaurants to create a circular economy? Farmers have been neglected. How do we keep ag land for ag (ongoing issue on Kauai).

(chat) Penny: We have special economic zones. How about traditional Hawaiian crop biodiversity zones that are tied to economic incentives for those growing traditional staple foods for local consumption?

(chat) Sarah Freeman: How is this department going to be funded? What is the departments budget going to be? And can you share how it is going to be structured? Also how many people do you imagine will be running this department?
