# Review Minutes and Today's Agenda.

- Scott Lehto reviewed the agenda, and it was accepted without additions or changes.

## **Finances**

• Dan Wiest reported we budgeted \$9,000 but we spent \$17,000. Most of the \$13,000 deficit this month was due to EMEAC donation, and the insurance not budgeted for. YTD for April, we have a \$7,000 deficit in pledges. He sent out pledge status this week and we are not doing badly on income, but our expenses are impacted. Bob's budget predicted \$7,000 deficits by April, and we are \$8,000 over that because of the EMEAC donation. By the End of April we are able to cover our deficit.

Dan Wiest will work on the budget for the Annual Congregation meeting.

#### **EMEAC Flooring / Al Acker's Memorial**

Al Acker's memorial service will be broadcasted, and Dan Secrest will set up the link.

#### **Farewell Plan**

- Scott distributed the plan for the Meeting and the committee reviewed it.
- Scott put together Nantucket limericks. He will reflect on his memories. Dan Secrest, Dan Hale, and Dan Wiest will speak. Kathy Stevens sent a text. Then Reverend Murray.
- Jody bought a going away gift, and that should be put in the closing.

#### Ministerial Search

- Steve Curtin interviewed Julie Brock, and two other people. Of these, Julie Brock will receive an offer, and Fred Wooden might be
  interesting to pull in as speaker. He is also a backup for Julie Brock if she turns down the offer.
- Scott Lehto presented the offer. A one-year, three quarter time contract, three Sundays per month, developing religious education program, supporting committee meetings, sermons on Sunday.
- July Brock will be available as soon as June 2022 and negotiated for more benefits. Original offer was 50 plus 12, but negotiated 55 plus 15.
- For pastoral care, she may have conflicts and the resolution was case by case review.
- Dan Secrest moved that we bring in Fred Wooden for speaker, Steve Curtin seconded, and all approved.
- Jody Wise was commended for leading the committee
