CRIMINAL COMPLAINT

1. INTRODUCTION

COMES NOW Plaintiff State of SimDemocracy (Hereafter referred to as “SimDem”, “SD”, “The State”, “Prosecution”, and the “Government”), by and through the Attorney General of SimDem, creative0690, and for it’s complaint against Defendant, Discord User “dictator_eugen” a.k.a. “dictator”, state as follows;

2. PARTIES

1. Plaintiff State of SimDemocracy is the Government of the SimDem Discord and Subreddit.
2. Plaintiff creative0690 is the Attorney General of SimDem, and its Chief Legal Counsel in this capacity.
3. Plaintiff Lucas is a state attorney who shall act as prosecutor for this case.
4. Defendant, dictator_eugen (1250053455985512470) is a citizen of SimDemocracy.

III. JURISDICTION AND VENUE

5. Venue is proper under the Criminal Code of 2020, Article 1, §1 and §2 as all the acts and conduct giving rise to the Complaint occurred in the SimDem Discord or in direct messages where both were a citizen.
6. The Court has personal jurisdiction over the Defendant as the Defendant is a citizen of SimDem.

IV. FACTS OF THE SITUATION

7. The Defendant sent a message saying that they liked a group of people for their Anti Semitism, in other words the Defendant said they like that group of people because they hate Semites or Jews in particular.
8. This form of speech is clearly demeaning, humiliating and upsetting for Jewish people.

9. The Defendant has stated that he does not believe the Armenian Genocide was a massacre but rather that it was a war.
10. The Defendant has also confessed without duress or any pressure that he expressed his opinion that the Armenian Genocide did not take place.
11. The Hateful Conduct Policy explainer of discord explicitly prohibits denial of violent events.
12. The Defendant put on a status on his discord account saying "You will swear for every Jew I have not killed".
13. This speech is trivializing the pain and suffering of so many Jewish people and is clearly demeaning, upsetting and humiliating for them.
14. The law provides that if speech is demeaning, humiliating or upsetting to a protected characteristic of people then it is assumed to be with intent to cause apprehension unless the defense can prove otherwise.

V. FACTUAL ALLEGATIONS

15. The State alleges one (1) violation of Article 53a §1, First Degree Hate Speech.
16. The State alleges one (1) violation of Article 61, Terms of Service Violation.
17. The State alleges one (1) violation of Article 53a §2, Second Degree Hate Speech.

VI. Relief Sought and Prayer

18. Plaintiff prays that the Court will grant the following:
19. A conviction and ban of 6 months for the one (1) charge of First Degree Hate Speech.
20. A conviction and ban of 6 months for the one (1) charge of Terms of Service Violation.
21. A conviction and ban of 3 months for the one (1) charge of Second Degree Hate Speech.

VIII. VERIFICATION

22. Under penalties of perjury, I declare that I am a certified attorney in the above-entitled action; that I have read the foregoing Complaint and know the contents thereof; that the pleading is true of my own knowledge, except for those matters therein contained stated upon information and belief, and that as to those matters, I believe them to be true. I declare under penalty of perjury under the law of the State of SimDem that the foregoing is true and correct.

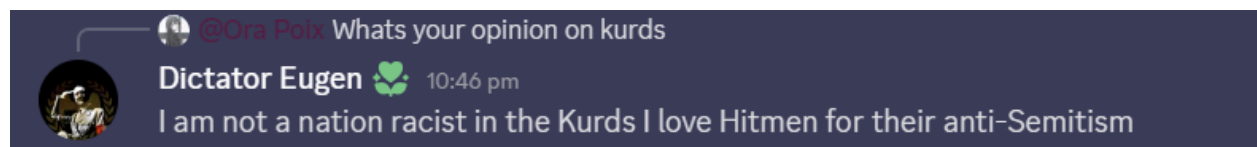

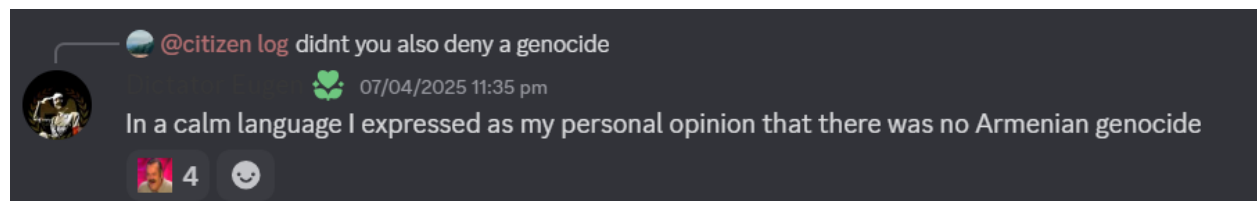
