RULES OF AGREEMENT

When purchasing my art services, you will agree to the following conditions. Please read through this thoroughly, I will deny your request should you refuse to follow instructions. PAYMENTS

All payments will be made in **USD**. I accept **Paypal** through **Ko-fi**. You may access my Ko-Fi [here](#).

- ◆ **Refund Policy:** Refunds are only available should I am unable to complete the commission within the deadline or if I offer it.
- ◆ **Payment Policy:** Full payment is required upfront for any commissions.
- ◆ **Split Payments:** I will only offer split payments for commissions that are \$400+ in total. You may pay the second half after the sketch is finished.



ARTIST

When you commission me, you are only purchasing artist labor only. I retain all copyrights over any art that I have created. This includes the right to use the image as a sample for sales/self-promotion unless otherwise agreed upon.

- ◆ **Privacy Respect:** If you do not wish your commission to be posted on social media, I will honor your request. No explanation required.
 - ◆ **Intellectual Property:** Any characters drawn are owned by their respective owners. I will not claim ownership, reuse/resell the commissioned piece for personal or commercial purposes unless agreed otherwise.
 - ◆ **Right to Decline:** If I am not comfortable with your request, I reserve the right to decline without explanation, especially if the request does not meet the guidelines.

CLIENT

After receiving your commission, you may upload the work done to any social media as long as it is credited and linked back to any of my social media. A list can be accessed via my carrd. You may also use the piece for any personal reasons, such as icons, signatures, layouts, desktops, etc.

- ◆ **Privacy Respect:** Please tell me ahead of time if you wish to keep your commission private. I will respect your request without any explanation.
- ◆ **Intellectual Property:** You will retain the rights to intellectual property (IP). If you are commissioning fanart of characters from other IPs, their ownership will belong to the respective creators.
- ◆ **Resale Policy:** You may resell the artwork for the original price or lower. This does not include reproduction purposes such as prints, merchandise, or similar items.
- ◆ **Commercial Use:** If you wish to use the commission in means of redistribution, reproductions, advertisements, or other commercial purposes, please contact me for details regarding royalty fees.



PROCEDURE

Please keep in mind that I will be working on your commissions to the best of my abilities. I do have health concerns that may cause delays on the deadline. Please do not commission me if you are wishing for a quick turnaround rate.

- ◆ **Workflow:** After receiving the payment, I will proceed with sketching, lineart, coloring, and so forth depending on the commission. You will be contacted throughout with updates at these stages.
- ◆ **References:** Please provide references for your commission request. You may include descriptions, but I will require artwork/photos/media in order to reference.
- ◆ **Edit Requests:** Please clarify any edit requests as clearly as possible. You will be able to request edits at each stage of the workflow.
- ◆ **Corrections:** Corrections will be free of charge unless asked to be edited after the confirmation of the finished commission. If you request to change something a week after I provided the final result, I will charge extra. Please tell me of any corrections during the process to ensure the best result for your piece.
- ◆ **Final Piece:** I will provide the full-size, unwatermarked version of the artwork. If sharing the artwork publicly, please use the watermarked version.
- ◆ **Communication:** You will be contacted via the method you have reached out to me. This includes email, Discord, or any social media messaging platforms.

THINGS THAT I WILL REFUSE TO DRAW

I will not draw any sexual violence/abuse, mechas, anything that is discrimination towards any person or group of people, political.

Please be sure to elaborate your request, I will notify you if I deny your request.



CODEWORD

The codeword is *Angel Bnuuys*.

Please put this as the title/subject/header of the beginning of your request, whether it be on social media or email.



DEADLINES

The usual deadline will be 1-3 months per commission piece. I will notify you if there is any delays, as I am chronically ill and will have times where it may be difficult for me to work on it. The maximum deadline is 6 months. If I fail to complete it by then, you may request for a refund as an option.
