The introduction is written as a paragraph, which comprises 10–20% of the total article length. It includes the background, rationale, a concise literature review, and the purpose of the study. It is written in Times New Roman, 11 points, with a single space. In each column, each paragraph begins with the first line indentation of 1.27 cm (1 tab) from the left margin.

Methods

Methods are described in detail, and references should be included for non-regular methods. It should include the design or research framework, research objectives, techniques, and data collection instruments that describe the data analysis approach.

Results

The results can be presented as graphs, diagrams/images, or tables, written with a single space and a font size of 10. The numbering should reflect the order of presence in the text. A total of six maximal tables are allowed. The use of footnotes is required for the explanation of any abbreviations that are not standard. Use the format A.1. a.1). a), and so on, for the numbering.




Figure 1. Cell ...

The discussion is the most important part of the entire content of a scientific article. The purpose of the discussion is to address the research problem, interpret the findings, integrate the research findings into the existing body of knowledge, formulate new theories, or modify existing theories using logical and systematic language.

Conclusions and Recommendations

The conclusion and recommendations address the research findings based on the research problems. The statements should be clear and not contain numerical values. The recommendations proposed should be logical and aligned with the research findings, avoiding any unfounded suggestions.

References

References should be from published manuscripts or manuscripts that have either been accepted or are pending publication (in press), these should be cited in the reference list. The reference formatting of Quality: Jurnal Kesehatan uses APA (American Psychological Association) style. All references should be derived from primary sources (books 50%, scientific journals other than vocational health journals 30%, and vocational health journals 20% of the total reference) and should have been published within the last 10 (ten) years. Each article should have a minimum of ten (10) references. The citation method used within the article content as well as the in the references list. The following is an example of a reference list:
