The length of full paper should not exceed 20 pages.

## **Heading 2 [Bold; Italic; Capitalise Each Word; Add space before and after paragraph]**

Meanwhile, for Quranic verses, the quotation and its translation should have 2-inch indent from left and right. The paragraph is justified. The name of *sūrah*, the number of *sūrah* and the number(s) of *āyat* must be mentioned afterward.
