→ Cardenas Markets Foundation Scholarship Program

- 64 scholarships totaling \$3,000 each will be awarded for the 2023 academic year.
- ◆ Due March 9, 2023

→ Auger & Auger Disabled Scholar Award

- ♦ \$1,000 scholarship for disabled undergraduate students
- ◆ Requirements: minimum 2.8 GPA, 500-1000 word essay
- ◆ Due July 31st for Fall semester, due November 30th for Spring semester

→ The David Malcolm Scholarship

- ◆ \$2,500 scholarship intended for students facing a current obstacle in their academic career (personal, family, situational)
- ◆ Requirements: minimum 3.5 GPA, max 1000 word essay
- ♦ Due June 30th

→ Sparks Law Dream Chasers Scholarship

- ♦ \$1,000 educational scholarship
- ◆ Requirements: minimum 3.0 GPA, 750-word essay
- ♦ Due June 30th

→ 2022 The City That Works Scholarship

- ♦ \$1,000 scholarship for a current high school senior, undergrad, or graduate student
- ◆ Requirements: minimum 3.0 GPA, 750-word essay
- ♦ Due June 30th

→ Keches Law Scholarship

- ◆ Two \$1,500 scholarships: one awarded to a current undergrad and one to an individual entering trade school.
- ◆ Requirements: a brief personal statement on how the scholarship would help further your education, 300-500 word essay
- ♦ Due June 30th

→ Future Lawyers of America Scholarship

- \$2,500 scholarship awarded to an undergraduate student interested in pursuing law
- ◆ Requirements: minimum 3.0 GPA, a demonstrated financial need, max 100-word essay
- ♦ Due June 21st

→ The Cunningham & Mears Academic Scholarship

- ♦ \$2,500 scholarship awarded to an undergraduate student interested in pursuing law
- ◆ Requirements: letter of recommendation, a statement of financial need, max 1000 word-essay
- ♦ Due June 21st

→ The Houtan Scholarship

- ♦ \$3,500 scholarship awarded to a student from any origin Iranian and non-Iranian who has high academic performance and a proven interest in promoting Iran's great culture, heritage, language and civilization.
- Requirements: Two letters of recommendation, essay on your goals and aspirations
- ♦ Due June 1st

→ 2022 The Law Offices of Scott Henry Scholarship

- ♦ \$1,000 scholarship awarded to a student who demonstrates a passion for the criminal justice system
- ◆ Requirements: minimum 3.0 GPA, 750-word essay on how the safety of your community, in relation to drinking and driving, can be improved
- ♦ Due June 1st
