I have carefully read this document, understand it fully, and by submitting payment, I consent to all parts of it. I acknowledge that I am voluntarily giving up certain legal rights by agreeing to this Event Waiver + Release.

Event Waiver + Release

Throughout this document, “Facilitator” refers to Ana Lilia and/or other event facilitators as individuals and Dream Bigger Media as an entity.

In exchange for participation in DREAM BIGGER Live (“Event”) organized by Ana Lilia of Dream Bigger Media and/or use of the property, facilities, meals, and services provided during the Event, I agree to the following:

I voluntarily desire to participate in the Event for the purpose of learning tools to release stress, examining my limiting beliefs, and empowering myself to show up for my goals. I take full and sole responsibility for my life and well-being and all decisions made before, during, and after the Event. I understand that no representations or guarantees have been made as to the business or personal results I may expect to receive before, during, or after the Event, and I agree and understand that I am 100% responsible for my actions and results before, during, and after the Event.

I acknowledge that I am choosing to participate voluntarily in various activities at the Event and I recognize that these activities may contain certain inherent risks, including exposure to COVID-19. I agree to assume any and all risks of participating in activities, including but not limited to: group discussions, meditation, breathwork, physical movement, spiritual work, coaching, and other movement or embodiment exercises (collectively “Program Activities”).

I understand I have the right to decline to participate in a Program Activity or to limit my participation based on my physical, emotional, or spiritual needs, and that I will inform the Facilitator if and when I wish to remove myself from any of the Program Activities.

I expressly assume the risks of the Event and all Program Activities. I agree to use caution while on the property, observe and obey all posted and announced rules and

warnings, and follow any instructions or directions given by the Facilitators, the property owners, or their employees, representatives, or agents.

I understand that the information provided at or in conjunction with the Program Activities and Event is not intended to be, nor is it a substitute for, professional medical advice, diagnosis, or treatment that can be provided by my own physician, therapist, licensed dietitian, or any other licensed or registered medical or mental health practitioner. I understand that the Facilitator and any of her representatives are not acting in any capacity as a medical or mental health care provider.

I agree to disclose to the Facilitator in advance any known food allergies or other allergies, physical limitations, prior injuries that may impact my breathing or movement, or any other health or mental condition. If I suspect that I have an immediate medical or mental health concern during the Event, I agree to inform the Facilitator promptly.

I agree to consult with my healthcare provider prior to and during the Event regarding any questions or concerns I have about my specific health situation, including possible or actual pregnancy, known or suspected allergies, or any medications I am currently taking. I understand that I am advised to speak with my own physician or mental health provider before attending the Event or implementing any of the Program Activities. I agree not to disregard or delay seeking professional medical advice or stop taking any medications without first consulting my own physician or mental health practitioner.

At any time before or during the Event, should I know or feel that I may cause imminent harm to myself, other participants, the Facilitator, or the property, I understand and agree that I am obligated to notify the Facilitator immediately and to remove myself from the situation in a peaceful and cooperative manner. I acknowledge that failure to do so may result in being asked to leave the Event and/or to receive immediate physical or mental health care to ensure the safety of all involved.

I agree to maintain respectful behavior throughout the Event. The Facilitators reserve the right to request that I leave the Event, without refund, if my behavior is deemed unsafe, disruptive, or inappropriate toward others or the space.

I consent to the application of first-aid or other emergency medical or mental health services if needed during the Event, and I agree to hold the Facilitator and her employees, agents, and representatives harmless as a result of any such care. I also consent that the Facilitator may contact my Emergency Contact if deemed necessary.

I understand that the Facilitator is not making any representations or guarantees as to the effectiveness or results of the Event. I agree that I am solely responsible for my goals and outcomes.

Participants are solely responsible for their personal belongings. The Facilitators and property owners are not liable for any lost, stolen, or damaged items during the Event.

Participants are also solely responsible for their travel to and from the Event. The Facilitators are not responsible for travel delays, cancellations, or other disruptions, including any expenses incurred due to such changes.

To the extent permitted by applicable law, I hold harmless, indemnify, and release the Facilitator, her representatives, and the property owner from any and all liability, damages, causes of action, allegations, suits, claims, or demands whatsoever, in law or equity, which I have ever had, now have, or may have in the future, arising from or related to the Event, including transportation to, from, and during the event.

In no event will I hold the Facilitator, her representatives, or the property owner liable for any direct, indirect, incidental, special, or consequential damages resulting from participation in or reliance on the Event or Program Activities. This includes, but is not limited to, personal injuries, accidents, illnesses, emotional distress, misapplication of information, or any other condition, even if advised of the possibility of such damages.

I agree to pay for any damages I cause to the property as a result of negligent, reckless, or willful actions on my part.

Photo & Media Release

I understand that photographs, videos, or audio recordings may be taken during the Event. I grant permission to the Facilitator to use such media of me for promotional purposes related to the Event or future offerings, unless I notify the Facilitator in writing before the Event that I do not consent to such use. We will do our best to respect your wishes and exclude you from promotional media.

Cancellation + Refund Policy

I understand that all payments made toward the Event are non-refundable. In the event I am unable to attend, I may transfer my spot to another individual with prior written approval from the Facilitator.

If I have selected a payment plan, I acknowledge and agree that I am responsible for paying the full balance, regardless of whether I attend the Event in full, in part, or not at all. I understand that my commitment to this payment plan is binding, and I agree to

complete all remaining payments according to the agreed-upon schedule.

Privacy + Confidentiality

I agree to honor the privacy and confidentiality of fellow participants. I will not share personal stories, experiences, or other information disclosed during the Event outside of the Event setting.

Severability

If any provision of this agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Governing Law

Any dispute concerning this waiver, the Facilitator, or any aspect of my participation in the Event or Program Activities shall be governed by the laws of the State of California.
