#### BACKGROUND OF JSA BOARD NOMINEES TO BE ELECTED

Morgan Connor is a lifelong sailor and has been a member of Noroton Yacht Club since 2012. Prior to joining Noroton, Morgan was a member of the New York Yacht Club for ten plus years. Morgan grew up sailing on Long Island Sound, sailing out of Ram Island Yacht Club as a junior sailor and progressing through high school and college sailing and eventually coaching the USC sailing team after graduating. This experience gives Morgan a deep understanding of the goals, challenges, and opportunities for both the Club Program Chairs and the sailors themselves as they navigate a path from junior sailing to the collegiate level. Morgan has been an active member at Noroton and is a prior board member and Co-Chair of the Noroton race committee. Today, Morgan regularly sails Sonars at Noroton participating in both fleet racing and team racing events. Morgan sails with his 15-year-old son Wells as they competed in the 2022 Sonar Worlds and 2022 Kirby Cub team race event. Morgan actively looks to instill his love of sailing with his kids and their friends. Morgan and his wife Suzanne have three children, 9, 13, and 15 with active participation in junior sailing at Noroton.

**Steve Houston** has just completed his two year term as the Junior Sailing Program Chair at the Shelter Island Yacht Club. In that role, he was responsible for working with the Club's sailing director to build the financial budget each year, organize recruitments and sign-ups, instructor hiring, instructor housing, regatta organization, spirit gear and trophy ordering, some dispute resolution and presenting to the Club membership twice a year. Steve has had three children go through the Club's junior sailing program and has traveled to regattas around the Long Island region, as well as Florida and Massachusetts. Steve sails his Herreshoff 12.5 every Saturday in the Club's racing series, and he regularly participates in PHRF races in and around the waters of Shelter Island. Steve is also a member of the New York Yacht Club and resides in Old Greenwich, CT.

**Dorsey Roseberry** joined Larchmont Yacht Club in 2000 and has been an active member since. She served on the Junior Sailing committee, was Co-chair of Larchmont Junior Race Week, and was Chair of the Junior Program for many years. Dorsey is a lifelong sailor. She attended and sailed for the College of Charleston (1990-1994) and was captain of the team in 1994. Dorsey has competed actively over the years in many fleets. She raced Interclubs, V15s, Lightnings, Vipers, Shields, as well as Can One racing and cruising on her family C&C 40. During her tenure as Jr Chair, Larchmont grew its race program, increased program size, and instituted many new programs to encourage the love of sailing for racers and non-racers alike. Dorsey has three children who have all participated in junior sailing and competed at various levels. Her oldest son was an active racer in both the Optimist and C420 fleets, and has competed nationally, internationally and at the college level. Her two oldest children, having loved their experiences in junior sailing, are both active instructors at Indian Harbor YC and American YC. Dorsey believes that the summers on the waters of Long Island Sound are formative for today's kids and she is always willing to help find a way for a new sailor to feel comfortable out there.

Melissa Mahoney Wirth grew up in Rye, NY and is a long time member of American Yacht Club where she and her brothers Ryan and Derek Mahoney grew up sailing in the AYC JAYC program. Most recently, Melissa completed her 1st year as co-chair of the AYC JAYC sailing program. Melissa is a graduate of Rye Country Day School and Middlebury College. She earned her Ed.M. and MA in Counseling Psychology from Teachers College-Columbia University in 2003. She works as the Manager of Alumni Relations at Rye Country Day School where she has been in various roles since 2005. She is also the girls' Middle School lacrosse coach. Melissa has three children Zachary(13), Emily(11), and Mason(10) who attend Rye Country Day School. Zack is a competitive C420 sailor and Emily and Mason are both racing in Optis in the AYC JAYC program. Melissa is an active member of the Rye community as a volunteer coach for both her son and daughter's Rye Youth Travel Soccer teams and her daughter's Rye Youth Travel Lacrosse team. She is also an elected Deacon in her second board term at Rye Presbyterian Church.

#### Minutes from the Annual General Meeting and Awards Presentation October 27, 2021 at Larchmont Yacht Club and Zoom Webinar

The Membership of the Junior Sailing Association of Long Island Sound, Inc. convened on the above date at Larchmont Yacht Club and by Zoom Webinar for the Annual General Meeting and Awards.

- 1. Co-Chair Janet Grapengeter opened the meeting at 1908; Secretary Rick O'Leary confirmed the presence of a quorum consisting of at least five regular member programs.
- 2. Secretary O'Leary presented the minutes of the 2020 annual meeting; a reading of the minutes was waived by motion and duly seconded.
- 3. Co-Chairperson Grapengeter invited Secretary O'Leary to briefly explain the election procedure set forth in the JSA By-Laws for board members.
- 4. Nominating committee member Richard West presented the report of the nominating committee as follows:
  - a. Co-Chairpersons: Janet Grapengeter and Alex Helfand.
  - b. Vice Chairpersons: Timothy Clark and David Waldo and Michael Cooleen.
  - c. Treasurer: Jonathan Arnold
  - d. Secretary: Rick O'Leary
  - e. Class of 2024: Ira Bigeleisen (CIYC), George Catallo (PWYC), Dorsey Roseberry (LYC), Mimi Shea (AYC).

A motion was made from a voting member, and duly seconded, to record a single ballot in favor of all nominees, upon which a unanimous vote of 'all in favor' was recorded by the secretary.

- 5. Co-Chairperson Helfand reported on the JSA overview and the US Sailing Strategic plan.
- 6. Executive Director Bob Whittredge announced upcoming events.
- 7. Co-Chairperson Grapengeter commenced the presentation of the special awards, including the Brooks Gonzales Award for Achievement, the Susie Trotman Award for Instruction, and the Mitchell Weeks Awards for Sportsmanship. The High Point Season Series Awards for outstanding results were presented, followed by awards for the Dorade Trophy and Beach Point Overnight big boat regattas. The awards concluded at 1951.
- 8. Following a short break, the Annual General Meeting reconvened at 1958, with open discussion topics:
  - a. Co-Chairperson Helfand noted participation of 42 clubs with 2,400 sailors (a participation rate higher than 2,286 in 2019, and 2220 in 2020), acknowledgement of a strong financial position, and discussion of a 'strategic survey' to be studied for future planning.
  - b. Co-Chairperson Grapengeter made an open request for comments and discussion, which was followed by discussion of the difficulties when hiring instructors. Further discussion took place

regarding retaining sailors and the potential benefits of social events like dances to reinforce the group dynamic. Additional general discussion continued regarding the use of 'Clubspot', the formation of the JSA 'Ocean Advocates", the benefits of Team Racing, and Environmental Science as experienced by developing an oyster garden as part of a junior sailing program.

- 9. The outgoing directors Sheelagh Thompson, Talal Debs, and Peg Jackson were thanked for their service to the JSA Board.
- 10. Co-Chairperson Grapengeter called for discussion of any old business as well as any new business, of which there was none.

There being no other business before the Board, the annual meeting adjourned at 2051 upon motion duly made, seconded, and carried.
