RE: Support for Maintaining 11th Street Redesign and Safety Improvements

Dear Mayor Whitmire and Honorable Members of the Houston City Council,

We, the undersigned coalition, express our strong support for Council Member Abbie Kamin's, Council Member Castillo's, and State Representative Morales' request to maintain and protect the redesign and safety improvements installed on 11th Street in 2023. More specifically, we urge the City to preserve the two-lane traffic configuration and protected bicycle lane, and to proceed with the installation of the planned HAWK pedestrian crossing. These improvements were developed through robust public engagement and are already contributing to a safer, more accessible corridor for everyone.

We recognize community perspectives evolve over time, and we welcome thoughtful future enhancements that further improve safety and mobility. However, we also believe that reversing existing safety improvements without consultation or transparency—especially at great financial cost—would be a disservice to our neighborhoods and the planning processes that brought them about.

Since its redesign, 11th Street has undergone a remarkable transformation. What was once a high-speed, dangerous thoroughfare is now a thriving and safe corridor. Each day, we witness more residents and visitors walking, biking, running, shopping, dining, rollerblading, pushing strollers, connecting with neighbors, and enjoying community events like festivals and markets. The street has become a vibrant, welcoming space that reflects the spirit and energy of our city.

This letter is not simply about opposing change. It is about the need for inclusive decision-making, fiscal responsibility, and honoring the voices of both our elected district leaders and the many residents who have contacted us directly. Our Council Members and the Houston Heights community deserve to be informed and consulted before substantial changes are made.

Furthermore, additional unnecessary construction would place strain on local businesses along 11th Street, disrupting operations and undermining the corridor's economic vitality.

We respectfully ask the City to protect the redesign and safety improvements now in place, avoid wasteful reversals, and ensure all future projects in our community are communicated clearly and developed collaboratively.

Thank you for your attention to this matter and your continued commitment to safe, vibrant, and well-connected neighborhoods.
