

## Red Thread Episode Show Notes - The Christory of Chris Chan - Part 3 (2019 - 2025)

Welcome back to our three part deep dive into the most documented individual on the internet - Christine Weston Chandler, more commonly known as Chris Chan. This is the third and final part to the trilogy, covering the years from 2019 through to the current whereabouts and activities of Chris. In our last episode, we covered 2009 through 2018, what many consider the "golden age" of Chris Chan documentation. We witnessed the systematic trolling operations against Chris, from the elaborate Jackie saga to the horrific destruction of his Sonichu medallion at the hands of BlueSpike. We covered the financial and emotional deterioration of the Chandler household following Bob's death, and Chris' transition from 'tomgirl' to publicly opening up about his transgender identity; even legally changing his name from Chris to Christine in 2016 (**note for viewers:** for the sake of consistency and minimal confusion, the script will once again be using the gender-neutral name of Chris and male pronouns, same as the last episode). We also witnessed serious legal issues following Chris and Barb's confrontation with a GAME PLACe manager, followed by mounting debt and shameless donation begging that became increasingly common in the years up until now.

Part 2 ended with perhaps the most damaging saga yet: the Idea Guys, whose organised efforts rewired Chris's entire belief system, while also extorting over \$6,000 from him. Though the so-called Guard Dogs stopped them eventually, the damage to Chris' psyche was already done. In October 2018, Chris announced the idea of the Dimensional Merge - a prophecy where the real world and his fictional cartoon worlds would collide. In this final part of the Christory of Chris Chan, we'll find out if this Dimensional Merge actually occurred, and what horrors were born from it.

## **2019**

Our final chapter begins in 2019, immediately starting with an incident in [January](#). Members of the online animated series [TF2 Analysis](#) - a fan made production crossover between My Little Pony and Team Fortress 2 - collectively decided to block Chris on Twitter following an unprecedented amount of post activity from trolls and Chris himself. A long-time follower and fan of TF2 Analysis, Chris expectedly didn't handle the blocking very well.

In response, Chris uploaded an unhinged [video](#) (0:38, 1:57, 5:17, 7:02) addressed to the "haters and bullies". The video mostly addresses the impending warfare between fictional heroes and villains in his foretold dimensional merge. His anger at the situation reached a breaking point on the 22nd of January, when he uploaded a [video](#) of him yelling hysterically into the camera, followed by an [apology video](#) (1:34, 2:43, 6:05) almost a week later apologising to the Brony members who blocked him. On the upside, he continued creating Sonichu content, releasing Sonichu Special 6 shortly after the meltdown.

The following [month](#), Chris started a new twitter account in hopes of reconnecting with the TF2 Analysis members and other Brony's who blocked him.

April was a chaotic month for Chris. Firstly, he released a [strange video](#) in which a masked man in a white suit pretending to be [Reginald](#) Chandler (Chris' fictitious son from another dimension) reads a poem which is written by Crystal Chandler - Chris' imaginary future daughter. The poem seems to discuss, yet again, the idea of a dimensional merging event.

Later in the month, Chris was [sued](#) by Recovery Portfolio Associates LLC for his mounting debt. He continued to beg for money from fans, but also showed off his [Poke Ball collection](#) just two days after being sued. Chris also watched [PewDiePie's](#) video 'The Legend of Chris Chan', although he wasn't much of a fan seeing as it didn't paint him in the best light. A few days later, Chris weighed in on the [Notre Dame fires](#), claiming that it was actually caused by a Pokemon.



Following a frustrating amount of fan mail being received at the Chandler residence, Chris responded with a [video](#) clarifying that PewDiePie did not live at 14 Branchland Court - once again doxxing himself online.

The summer of 2019 saw Chris' dimensional merge hysteria steepen - in a response to fan complaints that he wasn't producing any content for his paying Patreon fans, as well sustaining his long stint of unemployment (a reminder, Chris' last attempt at getting a proper job was signing up for a Multi Level Marketing company in 2003, sixteen years prior), Chris [declared](#) his preoccupation with the dimensional merge was consuming all of his time and mental energy. He

also shared that [Jesus Christ](#) himself will be a part of the merge, including any and all OC's (original characters') from other fictional franchised characters.

Yet another character who emerged in Christory around this time was [Jacob Sockness](#). Jacob is an autistic person who attempted to manipulate Chris into a sexual relationship, hoping to be his first male sweetheart. Similar to the Idea Guys before him, he tried to do this by exploiting Chris' escapist fantasies and his fictional world and by trying to convince him that his imaginary friend Magi-Chan approved of their relationship.

Jacob first emerged around mid-2018 when he discovered Chris and quickly became obsessed, buying multiple items from him, including [Chris' old shoes](#), but was mainly active in Chris' life from 2019, when he offered to work together financially by setting up a new eBay store, after [Chris' was banned in June](#). After this, now with his foot in the door into a relationship with Chris, he began to enable Chris by discussing his fantasy worlds with him. Jacob's manipulation got to a point where one of his own original characters, [Jakoba](#), was included in Sonichu #14.

**Jacob Sockness**



After a small period of relatively little interaction during the summer of 2019, by September they were establishing contact again. So much so, that on the 7th Jacob [faked a conversation](#) with Chris' character Magi-Chan, stating that in order for the Dimensional Merge to happen, Jacob and Chris would need to meet in person and get married. There was some back and forth about who would visit who, as Jacob was living in California and Chris was still in Virginia. By the 24th, Jacob announced that he had bought a train ticket to travel to Virginia to finally meet Chris. Rather ominously, this was a [one-way ticket](#). Fortunately, the day after Chris seemed to have a moment of clarity, likely thanks to concerned observers, and posted a [statement](#) urging Jacob to return home and not complete his trip to Virginia. The next day Chris [expanded on this](#), stating that his health was not well enough to have guests, but also claiming that Jacob had turned to evil. Luckily after some intervention from Chris' fans, Jacob gave up and returned home.

This wasn't the end of Jacob's interactions with Chris, though. He ended up [apologising](#) for previous emotional outbursts, and showed hope that he and Chris would get to meet in person at some point in the future. By October 2019, Jacob had gotten back in with Chris by helping him with his Patreon financing. Once again he started hitting on Chris via Twitter, which Chris played along with. Following this, Jacob began to manipulate Chris and turn him against everyone else, becoming the only person Chris could trust. Although Chris claimed that [he loved Jacob](#), he remained skeptical of him, and didn't fall for his manipulation to the same degree that he had with the Idea Guys. From this point, their friendship continued to sour and dwindle, with Chris eventually blocking Jacob and ignoring him in December of 2019. Jacob

made [some attempts](#) to reconnect with Chris up until 2023, however none have been well-received. It seemed that Chris was able to have some moments where he could distinguish fact from fiction, at least when it came to Jacob.

Aside from these incidents, 2019 showed signs of Chris' further degradation, both in terms of his mental state and his life. Some of the highlights include listing his house as '[Sonichu Headquarters](#)' on Google Maps and [larping as his character Magi-Chan](#) on Twitter for a couple of months. Financially, he was also still moving backwards. Earlier In June he had to go to [court for more unpaid debts](#) and was ordered to pay over \$2,600 to debt collectors. Supposedly during said court hearing he was [acting like a young child and making loud noises](#), which Barb had to continually shush him for. Lastly in November, more [debt collectors filed for garnishment](#) against Chris for unpaid debts, essentially meaning they were trying to siphon Chris' welfare payments to recover their owed money.

## **2020: Chris in COVID**

As we all know, 2020 saw the world thrown into chaos amid the most contagious outbreak the planet had seen in modern history - the coronavirus pandemic. Despite the global uncertainty, the Sonic the Hedgehog movie was released to theatres in [February](#) and was just as momentous for Chris, with him attending the premiere. Despite his earlier grievances, he actually enjoyed the film and spoke highly of it on [Twitter](#).

A week later, Chris attempted to console an underage girl online after she expressed her disgust after learning about her parents' sexual intimacy from her older brother. He did this by [telling her](#) of the time he saw his Dad's penis:

*"I can top that, easy: in my youth, I would run to wake up my mom and dad on some mornings. My dad slept with only a t-shirt on; no shorts or briefs at all. I saw his penis; it Grossed me out. Left me quite trauma-drama."*

Following backlash for his inappropriate oversharing, he blamed trolls for making him hate sex. Although the 17th of [March](#) marked the 20th year since Sonichu's creation, it was of course overshadowed by Covid, which was declared a national emergency in the United States the same month. People all over the country, and the world, were relegated to their homes for lockdowns and isolation. Many people struggled during this period, and Chris was no exception to this. Although his antics were subdued due to event cancellations and needing to stay indoors, his delusions and detachment from reality were once again on full display on Twitter.

Early into the pandemic, Chris also offered some [medical advice](#) to his online followers, suggesting they drink amethyst crystals in bottled water to prevent contracting the virus. However, this was just the tip of the iceberg for Chris' mental state and detachment from reality...



Most concerning for Chris, in April he announced on Twitter that he had [swapped bodies with Sonichu](#). This is likely one of Chris' coping mechanisms in response to BABSCon, a My Little Pony Convention, being cancelled due to the pandemic. Chris' escapist fantasies were in overdrive, with him believing that the body swap enabled him to attend BABSCon in his fictional dimension C-197. In the [tweet](#), larping as Sonichu, he said:

*"Mama [referring to Chris] successfully attended BABSCon in C-197 the past weekend and had a good time with some of her friends from 1218, as well as Everyone else there in attendance, including Dr Wolf and his friends."*

The rest of the tweet further shows Chris' detachment from the real world, with his trademark nonsensical ramblings. Despite his tendency to flit from one thing to another, Chris really stuck with this story. He committed to this body swap for almost a whole year, only finally [announcing his return](#) to his body in February of 2021.

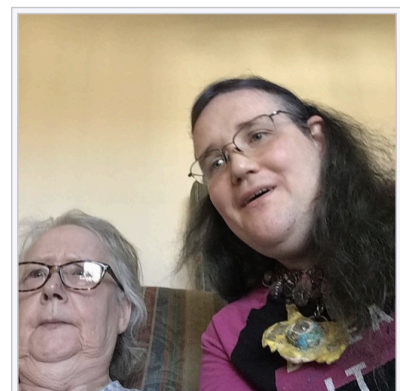
Other than the body swap, 2020 only had a few other incidents of note. In August, Chris recorded a video of his [last will and testament](#), which was leaked online. Of course, this [wasn't legally sound](#) or binding in any way, not least because Chris was in the midst of his body swap with Sonichu, so he naturally read the will as Sonichu. Seemingly unconcerned with the major life event of Chris' body swap, a couple of debt collectors also inconsiderately [sued Chris for more debt](#) in September, leaving him over \$3,600 further in debt. Also, despite his hatred of Donald Trump and support of Joe Biden, when the presidential election finally rolled around in November Chris apparently [voted for Lisa Simpson](#). Despite Chris' last minute defection, Joe Biden managed to win the presidential election.

2020 also saw Chris' first contact with [Praetor](#), a group who began producing and selling Sonichu and Chris-themed merchandise with Chris' permission. In return, Chris receives an undisclosed cut of the profits from items sold. This relationship still continues to this day, and in fact, the owner of Praetor (Caden Peck) would later buy a property in Big Island, Virginia where Chris currently lives and pays rent, further tying Praetor and Chris Chan together.

## **2021: Chris' Darkest Year**

In a life of constant internet scrutiny and controversies, 2021 might well have been THE year for Chris. And of course, it was for all the wrong reasons, this time in the *worst* possible way. The year started quietly enough, with Chris still in his "body swap" with Sonichu and expressing [feelings of loneliness](#). Chris turned 39 in February of this year, and allegedly returned to his body the day after.

The early months of the year were largely uneventful for Chris. In May, he posted an odd picture of himself with his mother

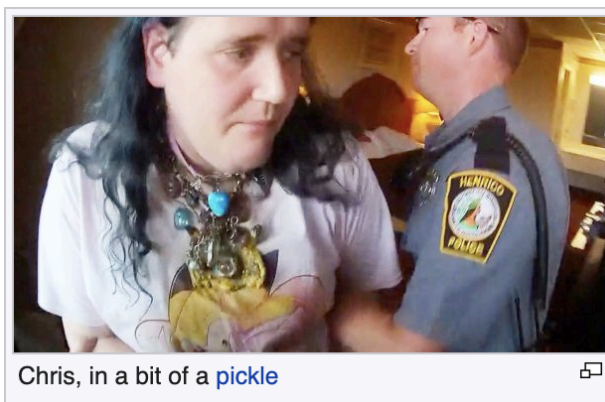


Barb for Mother's Day. He also went back to his old tricks of [begging for money](#) for a new car in June.

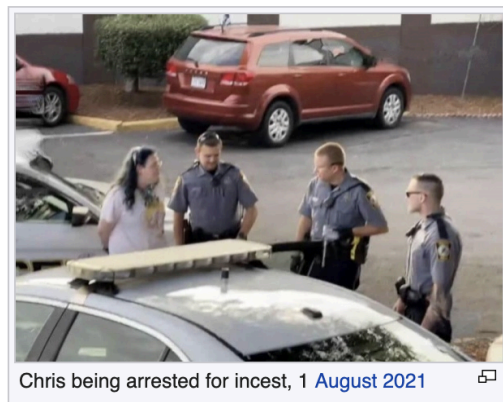
[July](#) seemingly showed an uptick in fortune for Chris, with him [bragging to multiple online friends throughout the month that he had found a new sexual partner](#). However, he was hesitant to reveal her identity, simply stating that she was an "older lady friend". In the meantime, he continued with some of his usual behaviour. Towards the end of the month, Chris uploaded a [short video](#) raging at Hasbro over the new generation of My Little Pony. In DMs exchanged with a follower by the name of Fiona Cooper, who apparently had a legitimate crush on Chris Chan, Chris shared images of him watching a [WatchMojo video](#) entitled 'Top 10 Hottest Anime Moms Ever'.

But all of this came to its horrendous peak when at the end of July, Chris finally spilled the beans about just who his new sexual partner was. In a call with one of his recent online friends, a girl by the name of [Bella](#) (known as Isabella Loretta Janke), he finally confessed that his new partner was none other than his own mother, Barbara. Although Bella is a can of worms of her own, and has often exaggerated or outright fabricated information, enough of the [Incest Call](#) (0:00 - 8:15, 18:26) was secretly recorded by Bella to be proven as fact. The recording was leaked soon after, along with [text messages](#) from Chris which also described the relationship and sexual encounters in explicit and horrifying detail. It turned out that Chris had been engaging in these atrocious acts [as early as June](#) 2021, supposedly every few nights.

For many onlookers of Chris' antics, this was a clear line in the sand, something so disgusting that far exceeded any "lolcow" badge that he had been labelled with for so many years. People called the authorities, and a [welfare check](#) was ordered for the household almost immediately after the leak. This resulted in Chris being removed from the house by an Emergency Protective Order (EPO), and Barb being taken to hospital for checks. Chris ended up temporarily staying at a motel, and transferring \$750 from Barb's bank account to himself. [Null](#), a long-time ally to Chris and the site owner of Kiwifarms, who had supported him through rough times, saw this transfer and [confronted him](#) about it, telling him that contacting Barb for money was a violation of his EPO. After initially denying the transfer happened at all, Chris eventually admitted to essentially stealing the money from his mother, citing that it was an emergency. This was the last straw for Null, who immediately [cut off ties](#) with Chris, blocked him and reported his actions to the police. Chris was then [arrested by police](#) on the 1st of August on suspicion of incest, all the while babbling about the Dimensional Merge. To add salt to the wound, in the span of roughly 24 hours, Chris also [spent all of the so-called emergency money](#) he had just stolen from Barb.

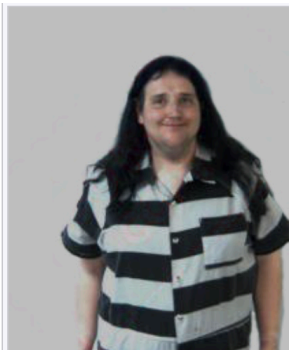

As if this whole sordid saga wasn't grim enough, [online speculation](#) also started to swirl after the news broke as to whether this sex would even have been consensual. It's worth highlighting the fact that this is speculation though, and there is no concrete proof either way, further muddying the waters.

The main argument that it wouldn't have been consensual is that in a lot of the videos that Chris filmed with Barb, she seemed to be generally showing signs of mental decline, possibly even dementia, although she did appear more mentally aware in some other videos. During the Incest Call, Chris also mentioned to Bella that Barb seemed "partially confused at first", but apparently she "came around". The relationship that Barb and Chris share is historically also far closer than most people would be comfortable with. However, Chris has claimed multiple times that it was consensual, and that he let her make the first move. Ultimately, a lot of this information is coming through Chris' very skewed filter, and Barb is not willing to comment further on the matter, meaning we may never know for sure.

Over the course of the next few days after his arrest, Chris was charged with incest and [transferred](#) to Central Virginia Regional Jail. His Patreon account was also suspended following the charges, and his license plates, registered as [SON-CHU](#), were stolen by trolls.

On the 4th and 5th of August, Chris made his appearance at [court](#). The case was moved to Greene County's Juvenile and Domestic Relations court, with Chris being represented by Charlottesville attorney David Heilberg. Greene County's attorney asked the presiding judge to deny Chris' bond out of concern for the safety of both the community and Chris - citing the public attention and streamers who were present at his arrest at the hotel. Chris then screamed out loud "I'm famous on the internet", to which he was quickly silenced and asked to speak only when spoken to. Judge Berrado ordered that Chris be held without bond, as he considered the high profile nature of the case to be a risk to Chris and the community. While Heilberg was requesting evaluation of Chris' mental state, Chris [interrupted](#) by stomping his feet and demanding his personal items be returned back home. Chris also interrupted Judge Barredo to correct the judge's quote of a statute, interjecting "she" when the Judge incorrectly read male pronouns. Barredo responded that he was simply reading directly from the state statute's wording.

On August 9th, Attorney Heilberg stated that his client was "legally disabled with mental health issues". While held in jail before his next hearing, Chris wrote several letters. [One](#) of which, on the 20th of August, begs for more money and undergarments:

*"Hey, everyone. I would very much appreciate paying off my jail debt. And being able to purchase from the jail's Commissary; I REALLY Need New Socks, a Bra, some extra panties, and a pair of Leather*

*Sneakers, and other goods, from this. So, Please, all of you, go online and Donate to my Inmate Account right away. Five or Ten dollars per person, at least, towards an accumulated total of \$100 would be Very Much Appreciated."* On the 29th, Barb was returned to her home on Branchland Court. She eventually got back in phone contact with Chris once the EPO was lifted around a month later.

### **2021 through to 2023: Chris' Time in Jail**

With Chris in jail, [September](#) was a mostly silent month with the exception of a letter on the 19th. The [letter](#) revealed that Chris was taking a keen interest in the Bible, and believed that he himself was Jesus Christ of Nazareth - compounded with his other preexisting delusions of the dimensional merge.

Chris drew this comparison with Jesus Christ after seeing similarities with Jesus' persecution and his own, as well as physical appearance - ignoring the fact that this "uncanniness" is predicated on the Western artistic depictions of a caucasian Jesus, rather than a middle-eastern Jew.

*Firstly, and Vitally, it should be made obvious and clear that aside from Andy Warhol, my life events at present and so far can directly be compared and matched with that which have been chronicled of none other than Jesus Christ of Nazareth himself, in any Holy Bible, Also, feel free to take ANY unaltered original photograph of my body's face, neck and shoulder/chest area where I was not wearing the glasses. Then, alter the photo to show a naturally growing brown beard, mustache, and sideburns. Now, place that photo next to any image of Jesus on of off the cross; compare, look deep into my eyes and photograph; see for yourself, I meditate and connect, directly and genuinely with the Cosmos, both of our Universe halves, and throughout the timelines, and entire Multiverse, so despite some lack of "Physical" evidence, I Know the ultimate Truths, Facts, and Details not commonly known or written, drawn, or chronicled.*



As well as his declaration of being a prophet, Chris' [letter](#) also downplayed the severity of his actions - suggesting that the sexual relationship with his mother was an instruction from God to heal and cleanse his Mother, emotionally and physically (as he had done so with several others "back in Israel over 2000 years ago").

With Chris' next hearing delayed to November, Chris spent [October](#) in jail - writing [several more letters](#), one of which being a response to a failed attempt from a fan to convert Chris to





Islam. Barb turned 80 on October 1st - with Bob dead and Chris in jail, it was her first birthday alone in decades.

Chris' hearing was again pushed back again in [November](#) - this time to February the following year, 2022. To pass the time, Chris remained in frequent contact with the outside world and fans, through [phone calls and letters](#). A [letter](#) on November 8th provided insight into Chris' true mental state in jail - claiming that astral projection had allowed him to visit other locations while locked up. He shared that he also was kept away from other inmates, and filled his days by meditating and playing cards. Another [letter](#) written later in the month claimed that the dimensional merge had taken place - and that his cell room was filled with his imaginary characters including Magi-chan, and his "hubbychu".

Chris closed out the year by spending his Christmas holidays behind bars. More [letters](#) and conversations were shared with his fandom, [one](#) requested a fan to send \$200,000 to his donations account immediately. Another letter included a new and improved [ten commandments list](#). Some of these revised commandments instructed followers to worship any or all gods, or none at all - "which ever best feels well and good with thee", and that adultery is perfectly acceptable, rather ironically, so long as it's disclosed with your partner and not in secret.

2022 was naturally a much quieter year for Chris, given that he was in jail for the entirety of the year. This meant that he spent his [40th birthday behind bars](#). Around the same time, he was also [transferred](#) from Central Virginia Regional Jail to Western State Hospital due to his incompetence to stand trial, and as a result [March](#) was one of the quietest months in all of Christory. By [May](#), he was transferred back to jail and slowly started to get back into the process of writing letters to friends and drawing [pictures for sale](#) by Praetor.

Chris' court proceedings kept getting delayed throughout the year, but by the [28th of July](#), his incest charge was certified to go before a Grand Jury, meaning it was being prosecuted as a felony. August was a busy month for legal proceedings for Chris. His lawyer filed for an [autism disorder deferred disposition](#) in an effort to get the case dismissed, which further extended the court proceedings. The court scheduled a review for his case in a year's time. The court also decided to seal the case, due to trolls pestering for information about the case and the subsequent worry that misinformation about it would be spread. Despite this, select information was still made public by the court.

Moving into [2023](#), Chris was still in jail for the early months of the year, including his 41st birthday in [February](#); his second birthday in a row spent in custody. Again, his court hearings kept being rescheduled, albeit for shorter spaces of time than the previous year. However, on the 27th of March, after a year and seven months in custody, Chris was released from jail by court order. After some periodical reviews between March and August, the main review that was



scheduled by the court from the year before was held on the 8th of August. With the autism disorder deferred disposition filed by his lawyer the year before, the court [dismissed the incest charge](#). He was not formally charged, and aside from being held in custody, he essentially got out of the entire incest saga without any major consequences.

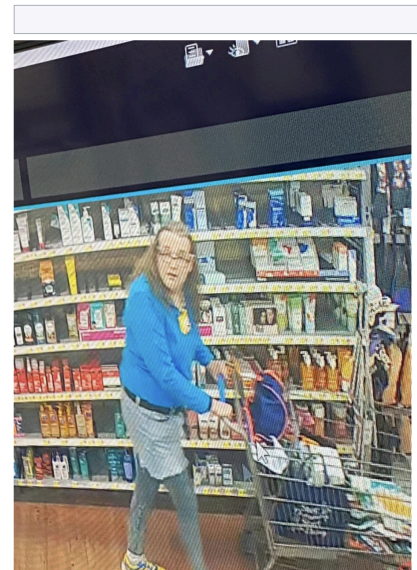
### **2023: Chris Returns to the Public**

Between his release from jail and the case being dismissed, Chris was only sporadically seen in public. His first sighting wasn't until [May](#), being seen at places like Walmart and various game stores. By the end of May, his appearance had gone through yet another transformation, with him dying his hair a bright teal colour and changing up his [fashion sense](#) again. He also took to signing his name as "[J. Christ Chan Sonichu](#)". By [August](#), Chris slowly started reestablishing his online presence by playing Pokémon GO, his newly bought PS5, and progressively liking more and more tweets. He also marked his return to posting by uploading previously unreleased artwork from his time in jail onto DeviantART. It seemed that Chris just couldn't stay away from the internet.

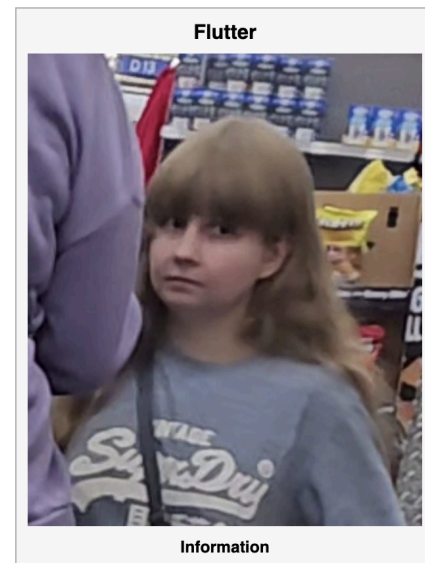
By [September](#), Chris was being spotted in public more and more. Curiously, however, in some of these sightings he was also accompanied by an unknown woman. Chris could even be seen touching, hugging and even kissing this woman. Eventually, this woman was revealed to be [Flutter](#), a woman who had gotten in touch with Chris while he was in jail and had since met up with. Little else is currently known about her, and it is not confirmed whether the two are actually dating or not, however they have continued to be spotted together since this time.

Finally, October 2023 brought with it the inevitable return of Chris to the internet. He released his first video in over two years on the 16th, with the title "[Jesus Christ Chan Sonichu Prime Resurrected and Returned](#)" (8:07). As if the title wasn't enough of a giveaway, the video is pure nonsense, lasting 9 and a half minutes and mainly consisting of Chris poorly singing a couple of Pokémon parody songs along with clips of him dancing in front of a green screen. After each of the songs, Chris speaks briefly about his return. Although, to anyone other than the most adept Christorians, Chris' words just come across as nonsensical ramblings.

Information

The following day, Chris uploaded another video titled "[Setting the Record straight - there never was any sex involving me in 2021](#)". In this video, Chris denied the incest allegations, even going so far as to claim that he was "proven innocent in a court of law" - an outright lie as his case was dismissed - and blaming others for manipulating him, including Bella and his online trolls. He also once again claimed that he is the reincarnation of Jesus Christ. It seems that no matter how much Chris' mental state deteriorates, he will always have the victim complex and never admit any fault.

From this point, Chris was back to his regular online antics, starting to post more frequently on Twitter and YouTube. He also started streaming, which was a new avenue for trolls to harass him. One particular [moment of note](#) included Chris breaking from his lighthearted mood to becoming silent and looking extremely uncomfortable when someone donated \$1 and left a scathing comment:

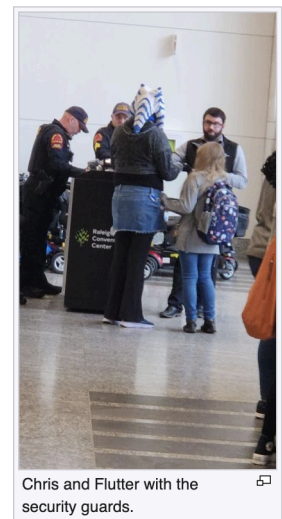
*"You raped [your] mother and then bragged about it, Chris. The only reason you're denying it is because people are upset with you. Enjoy your dollar. Don't spend it all in one place."* (**can be seen at [1:50:38 in the livestream](#)**)

Chris' expression after reading the comment and the resulting uncomfortable silence are palpable, with some speculating that his expression is one of pure guilt or shame. In his efforts to recover, he then jumped to the next question that someone asked about the Sonic Prime TV show and continued on with the stream.

Chris' excuses and explanations for the incest allegations also continued to become more and more convoluted as the year went on. In a November [livestream](#) when asked about it by a viewer, he went on to explain that he played along with the allegations so he would be sent to jail to [avoid meeting Jacob Sockness](#) at a My Little Pony convention in Washington state that he had been planning on attending. He also started to ramble about accessing memories of the incest from another dimension where a different version of himself had sex with Barb, and that was somehow how he was able to go along with the allegations. While answering the question he also said that Null "stabbed [him] in the back" for refunding donors for Chris' travel to the convention after the incest news broke. Curiously when answering another question in the same livestream, he claimed that his autism had been mostly cured thanks to meditation and affirmations.

## **2024 and 2025**

Overall, [2024](#) was another quiet year for Chris. Only a couple "incidents" of note occurred, both of which were in relation to conventions. On the 5th of January, he and Flutter attended [Animate! Raleigh](#). At the convention, Chris asked a [largely gibberish question](#) at an Aqua Teen Hunger Force panel, which confused the speakers. However, when they attended the next day, they were denied entry by security and banned from the event for unknown



reasons. The second incident happened in March regarding BABScon, the My Little Pony convention whose cancellation during COVID caused Chris to swap bodies with Sonichu back in 2020. Since being released from jail, Chris had been showing interest in attending the convention, however the organisers of the event nipped that in the bud by notifying him that he was [banned from the event](#) before he could attend. In Chris' reply to their email, he brings up his LGBTQIA+ identity and that he has high-functioning autism, despite previously claiming that his autism was mostly cured the year before.

November was another somewhat busy month for Chris, as he once again became invested in the Presidential Election, this time backing Kamala Harris rather than Lisa Simpson, complete with [hand-drawn pictures](#). However, Kamala's loss ultimately didn't seem to end up phasing Chris compared to Trump's previous win. It was also around this time that rumours began to spread that Flutter was pregnant. Chris [outright denied these rumours](#), which have since been proven to be false.

Aside from these incidents, not much can be said for 2024. Chris still occasionally livestreamed throughout the year, usually promoting items for sale via the online store that Praetor set up, however even these were more sporadic than the year before. In fact, outside of intermittent sightings in public, we once again saw a few months of the year where Chris was hardly active online at all. This was partly explained eventually, as Chris and Flutter were both spotted in [Finland](#) three separate times throughout the year, in April, September and December. These are the first times that Chris is known to have left the United States. Chris and Flutter have also been seen in Finland twice so far in 2025, in March and July.

What's curious about these Finland visits is that Chris has been uncharacteristically tight-lipped about them. In fact, he has outright denied that he has ever been to [Finland](#) or that he has been learning Finnish on [Duolingo](#), despite there being overwhelming evidence to the contrary. Considering that Chris couldn't even keep his alleged incestuous affair to himself, this has captured the attention of his followers and sparked theories as to why the sudden secretive responses to Finland. The most commonly accepted theory is that Flutter has Finnish heritage, or even potentially lives there and just visits Chris periodically. The speculation and mystery grew further, when on their fifth trip they were seen in Rauma, a small town with just 30,000 residents located 250 kilometres away from the capital of Helsinki. To date though, the true reasons behind these Finland visits remains a mystery.

The only other main incidents of note from 2025 are that Chris has moved away from livestreaming and instead gone back to more pre-recorded videos. In May, he posted a [video](#) complaining that he was receiving too much hate from viewers on his streams and threatened to stop streaming altogether. So far, he has uncharacteristically stuck to his word about this, sticking to pre-recorded videos.

## **Conclusion**

And that's where Chris Chan's story currently ends. Although we are left with some unanswered questions and mysteries which we can only assume will become clear in time, we have also been left with a cautionary tale of sorts. Over the course of Chris' life since his discovery by the internet in the late 2000s, we've seen someone who couldn't help but post anything and everything online, however innocently motivated at first, and being exploited by trolls as a result. We've seen Chris' mental state and grip on reality deteriorate over time, and we've seen a life of low points that somehow defy all expectations by continuing to find new depths. Countless times, we've seen Chris be genuinely victimised by others as well as victimise others himself, all the while shirking any and all responsibility for genuine wrongdoings.

After learning about Chris' convoluted history, one can't help but wonder how his life might have turned out had he never been discovered by online trolls. If people like BlueSpike and the Idea Guys hadn't permanently affected his mental state, or if he had managed to get a job and leave home, for example. Regardless, this is the world we live in - [1218](#), as Chris would call it - and Chris Chan will forever be in the internet history books, for better or worse, with his status as the biggest lolcow in history now seemingly unassailable. What Chris will do next in life no one can possibly know, but rest assured, the world will be watching and documenting.
